FUNCTION THEORY FOR A BELTRAMI ALGEBRA

<u>ABSTRACT.</u> Complex functions are investigated which are solutions of an elliptic system of partial differential equations associated with a real parameter function. The functions f associated with a particual parameter function g on a domain D form a Beltrami algebra denoted by the pair (D,g) and a function theory is developed in this algebra. A strong conformality property holds for all functions in a (D,g) algebra. For $g \equiv |z| = r$ the algebra (D,r) is that of the analytic functions.

1. INTRODUCTION.

The idea of defining classes of functions which are generalizations of the analytic functions by means of systems of first order partial differential equations goes back at least to a paper of Picard in 1891 [1]. The solutions of that system were of the type later called "pseudo-analytic functions of the second kind" by Bers [2] where for f = u+iv

where a, b, c and d are appropriate real-valued functions. The relationship of solutions of the elliptic system

where a, b, c and d are real valued and $bc-a^2 = 1$, to those of system (1.1) is well developed in papers by Caldwell, [3, 4]

Two current research areas related to the early investigations of elliptic systems are the theory of guasiconformal mappings and function theoretic methods in partial differential equations. Works from the latter point of view which have B. A. CASE

extensive references are Vekua, [5] and Gilbert and Buchanan, [6]. Ahlfors discusses, in his introduction to [7], analytic theory generalizations and rationale concerning quasiconformal mappings in particular. Examples from the algebras of functions which we consider are found in very different areas of investigation, indicating the possibility of an interesting and useful function theory. (e.g., Concerning quasiconformal mappings see [8], p. 71; topological analysis, [9] and [10], p. 198; elliptic systems of partial differential equations, [5], p. 131.)

The functions considered are solutions of a Beltrami differential equation with complex dilatation at each point z dependent on a real parameter function g. A generalized derivative f'_g is defined. Necessary and sufficient conditions for existence of f'_g include the Beltrami equation which reduces to the Cauchy-Riemann equations for analytic f. Both re f and im f satisfy the same second order partial differential equation with analytic antecedent the Laplace equation. Although the available generalization of the Laplace equation and its applications are of interest in any elliptic system, the parallel is not always so direct. (e.g., In the system of [11] a different generalized system holds for each of re f, im f.)

For functions in algebra (n,g), a generalized conformality holds which is invariant in the algebra, that is, for given z and two fixed arcs the angle between the image arcs is the same for all functions in the algebra. The generalized line integral g f shares in modified form much of the theory of the ordinary complex line integral. Among some applications in the last section is a function continuous on the finite complex plane, in a (D,g) algebra on $-\{(0,0)\}$, K-quasiconformal on bounded sets, and which maps ϕ onto a fixed open disk.

2. NOTATION AND DEFINITIONS.

Complex valued functions of one complex variable $z = re^{i\theta} = x+iy$ are denoted f and re f = u , im f = v , $|f| = \rho$ and arg f = ϕ . Partial derivatives are denoted by subscripts. Standard definitions used are:

The complex plane is denoted \uparrow and a domain $D \subset c$ is an open connected set (and, later in the paper, is required to be simply connected). The classes $C^n \mid C^{\infty} \mid$ comprise the functions with continuous partial derivatives of n [all] orders. Usage is generally consistent with [12] and [13] as concerns classical analysis; [8], [7] and [14] as concerns quasiconformal functions; and [15] as concerns functional analysis.

The derivative f'_g defined here is the limit of a generalized difference quotient involving the parameter function g which reduces to the difference quotient for analytic functions. For $f \in C'$ in a domain, existence of the limit of this generalized difference quotient is shown in [16] to be necessary and sufficient for our defining condition (2.2 below).

DEFINITION 1. A parameter function g in the following discussion is a real valued positive function of |z| = r for $z \in D$, such that g' = dg/dr exists and is continuous on D.

For such functions the generalized derivative is defined

$$\mathbf{f}'_{\mathbf{g}} = \mathrm{e}^{-\mathrm{i}\,\theta}\mathbf{f}_{\mathbf{r}} \quad . \tag{2.3}$$

A function is called <u>g</u>-analytic at a point z when there is a parameter function g so (2.2) holds on some domain containing z; f'_g is called the <u>g</u>-derivative.

The Reltrami equation (2.2) is equivalent to a generalized Cauchy-Riemann condition. When stated in rectangular coordinates in the form (1.2) the functions a, b, c are: $a = xy(g^2 - r^2)/gr^3$; $b = (x^2r^2 + y^2g^2)/gr^3$; $c = (y^2r^2 + x^2g^2)/gr^3$. For computational convenience we state that condition as a system in polar form

DEFINITION 3. Let f be complex valued and continuous on (piecewise) differentiable arc γ on which $r \neq 0$. A generalized line integral dependent on parameter function g is defined by:

The properties of the lemma follow from the definitions in a straightforward manner.

LEMMA 1.

a) When $f \in (D,g)$, $J = (g/r) |f_r|^2$.

b) The constant functions are in each set (D,g) and are the only functions in $(D,g_1)\cap(D,g_2)$, $g_1 \neq g_2$; $f'_g \equiv 0$ for a constant function.

c) If $f \in (D,g)$ and $f'_g \equiv 0$, then f is constant. Also, f is constant if either ref, im f, |f| or arg f is identically constant.

d) If $f \in (D,g)$ and c is a complex number, then $cf \in (D,g)$.

e) If f , h ϵ (D,g) then the sum, product and reciprocals are in (D,g) (1/f for $f \neq 0$) and the generalized derivatives are:

f) If f, h ϵ (D, g) such that $f'_g \equiv h'_g$ on D, then f-h is a constant function on D.

g) If nonconstant $f \in (D,g)$ and $h \in (D,r)$ then $h \circ f \in (D,g)$.

h) (D,g) is an algebra over \oint . (The multiplicative unit is $f \equiv 1$.) For $g \equiv r$, (D,g) is the set of functions analytic on D, and (2.3) and (2.5) are, respectively, the usual derivative and line integral. The requirement in Definition 1 that the function g be positive is equivalent to requiring that the Jacobians for functions $f \in (D,g)$ be non-negative and hence that the functions be sense preserving. This is consistent with practice in the larger quasiconformal class although, as there, many of these results hold for sense reversing functions. Other conditions on f or g in the definitions may be weakened in some annihilations. See [17], [4] for careful discussion of topological and quasiconformal properties of Beltrami systems.

3. MAPPING PROPERTIES

Functions which are solutions of the Beltrami equation (2.2) are locally quasiconformal. In particular, at $z \in D$ the dilatation quotient is given

The dilatation quotient is bounded on every compact subset of P and, if it is bounded on P then f is a regular K-quasiconformal mapping for

$$\frac{K}{z \in D} \max \{ p/r, r/g \} .$$

A strong generalization of conformality holds for p-analytic functions. Given a point z and the parameter function g, the angle between the images of two fixed arcs is the same whichever $f \in (n, p)$ maps the arcs. This reduces to angle preservation in the conformal case. It is more specific than the inequality available for the larger class of quasiconformal mappings in general. (See [18], Theorem 4, which is an equivalence to quasi-conformality.)

THEOREM 1. Arcs γ_1 and γ_2 intersect at z where they have tangents which make angles respectively of α and β with the real axis and of σ and τ with the radial direction through z. If $f \in C^1$ is g-analytic in a domain containing z then the angle ψ' between $f(\gamma_1)$ and $f(\gamma_2)$ is determined by:

Conversely, if $f \in C^1$, $T \ge 0$, and (3.2) holds on some domain containing z where g satisfies Definition 1, then f is g-analytic at z.

PROOF. The second of the forms of (3.2) is most convenient to derive. The first then follows, since $\sigma = \alpha + \Pi - \theta$, $\tau = \beta + \Pi - \theta$. Let σ' be the angle made by $f(\gamma_1)$ at the point f(z) with the radial direction through f(z). Manipulating algebraically with allowable angles, we have

Since $f \in (D,g)$ by hypothesis, substitution using (2.4) gives (3.2).

Conversely, if f is a function for which the expressions (3.2), (3.3) are equivalent for all arcs, then

which is equivalent to the complex form of (2.4); since J > 0, f is sense preserving, hence f is g-analytic.

DEFINITION 4. If $f \in (D,g)$ and f satisfies (3.2) locally for all $z \in D$, then f is <u>p-conformal</u> on D.

For all functions in a given (n,g) algebra, the g-conformality gives the angle between the images of intersecting arcs depending on the tangents to the arcs themselves and the point at which they intersect. In the algebra of analytic functions (D,r) the relation is not only also independent of the **intersection** point but, reducing to angle preservation, is the same for all pairs of arcs (γ_1, γ_2) with the same angle between them. The similarity to the analytic case is less obvious in the case of the effect of the g-analytic function on arc length. Where ds and dS are elements of arc in the z and f(z) planes, respectively,

The modulus of the generalized derivative retains position as a magnification factor, although not in the Euclidean metric.

4. PROPERTIES OF THE FUNCTION THEORY

In addition to some theory of the generalized derivative (2.3) and integral (2.5), we give a generalized harmonicity relation which is satisfied by both re f and im f for f in a (D,g) algebra. It is helpful to first construct two examples which are the most general functions in a (D,g) algebra under certain conditions.

From now on, we assume a domain D is a simply connected. EXAMPLE 1. If at $z \in D$

where c_1 , c_2 are real constants, $c_1 \neq 0$, and nonconstant real valued $\lambda(r) \epsilon C^2(D)$, then f is g-analytic at z and $g = c_1 \lambda / \lambda'$. On the other hand, when f_1

is a g-analytic function of form (4.1) then

EXAMPLE 2. If $f_2 \in (D,g)$ and (re $f_2)_{\theta} \equiv 0$, then there exist real constants c_1 , c_2 and a branch of arg $z = \theta$ such that

when $h \in (D,g)$ and $(reh)_r \equiv 0$ then $h \equiv if_2$, where f_2 is as (4.3). The statement follows since $(im f_2)_{\theta}$ is independent of r and $(ref_2)_r$ is independent of θ , so that there exists real c_1 such that $(im f_2)_{\theta} = g(ref_2)_r = c_1$.

We consider two relationships between the example functions of (4.2) and (4.3). Clearly $f_1 = h \circ f_2$ where h is the exponential function. By Lemma le on composition of functions f_1 is granalytic if and only if f_2 is granalytic. Also, the graderivative of f_2 is given by $(f_2)'_g = (c_1/g)e^{-i\theta}$ which is a function of the form of (4.1) and hence is e_1 -analytic for $e_1 = p/g'$. Now, in general, if we require the function of form (4.1) to be in (n, e_1) we note that $f'_g =$ $\lambda' \exp(i((c_1-1)\theta+c_2))$ and $e_1 = c_1\lambda/\lambda'$. It follows by mathematical induction that the kth derivative exists under appropriate conditions. (See Theorem 3b.)

Theorems 2 and 3 discuss the existence of higher order derivatives.

THEOREM 2. Let $f \in (D,\lambda)$ and $z \in D$, then f' is g-analytic at z for real positive function $g = \delta$ only if at least one of the following conditions holds:

a) There is a real number k such that $\lambda(\mathbf{r}) = \mathbf{r} + \mathbf{k}$; for this case $\delta = \mathbf{r} + \mathbf{k}$.

h) There exists real valued differentiable $h(\theta)$ such that $(im f)_r = h(\theta)(re f)_r$.

c) Fither (re f)_A or (re f)_r is zero.

PROOF. Let f = u + iv; then re $f'_{\lambda} = \cos\theta u_r + \sin\theta v_r$; im $f'_{\lambda} = \cos\theta v_r - \sin\theta u_r$. Requiring that (2.4) hold for some real $\lambda(r)$ gives the matrix equation

If the third matrix is the zero matrix then we have a). When u_r or v_r is zero, we have c). (See Fxample 2, (4.3).) Otherwise, the requirement that $u_r v_{rr} - v_r u_{rr} \equiv 0$ implies the relation of b).

THEOREM 3.

a) If $f \in (D,g)$ for g(r) = r+k, then $f_{r+k} \in (D,g)$. If $f \in C^{\infty}(D)$, all orders of higher derivatives exist in (P,r+k) and are defined by

b) If $f \in (n,g_1)$ is of the form $f = \lambda \exp(i(c_1\theta + c_2))$ where $g_1 = c_1 \lambda / \lambda'$, then the nth derivative exists for

In particular, where $e_n = (c_1 - n + 1)\lambda^{(n-1)}/\lambda^{(n)}$, then

$$((f'_{g_1})'_{g_2}...)'_{g_n} = \lambda^{(n)} \exp(i((c_1^{-n})_{\theta} + c_2)) .$$

(When $c_1 \leq 0$ and $\lambda \in C^{\infty}$ all orders of higher derivatives exist.)

c) If nonconstant $f \in (D, \lambda)$ with (ref)₀ = 0 or (ref)_r = 0 then the first derivative exists and reduces to case b). (See the discussion following Example 2.)

PROOF. a) and b) can be proved using mathematical induction.

If f is in an algebra (D, p), then both ref and im f satisfy the same second order partial differential equation which is the Laplace equation for analytic f. In a simply connected domain construction of conjugate g-analytic functions follows.

DEFINITION 5. Real valued $\phi(\mathbf{r}, \theta) \in \mathbb{C}^2$ satisfying (4.5) is called e-harmonic. Real functions $u(r,\theta)$ and $v(r,\theta)$ which satisfy (2.4) are called g-conjugates.

THFOREM 5. If ϕ is g-harmonic in P, then ϕ has at least one gconjugate.

PROOF. Without loss of generality, let u satisfy (4.5) and consider $v(r,\theta) = \int_{0}^{r} -u_{\theta}(r,\theta_{0})dr/g + \int_{0}^{\theta} e^{-u_{r}(r,\theta)}d\theta$ where z_{0} is a fixed point $z_{0} = r_{0}exp(i\theta_{0})$. It is immediate that $v_{\theta}(r,\theta) =$

 $gu_r(r, \theta)$ and we also compute

$$v_{r}(r,\theta) = -u_{\theta}(r,\theta_{0})/\epsilon + \int_{0}^{\theta} (\lambda u_{rr}(r,\theta) + \lambda' u_{r}(r,\theta))d\theta$$

which after substitution of (4.5) reduces to $v_r = -u_{\beta}/g$, satisfying (2.4) for f = u + iv.

Examination of Definition 3 of the g-integral as an Riemann path integral involving the function g shows that the usual operational properties regarding multiples and path components continue to hold. We derive a few useful properties of the generalized line integral; in particular these are analogues of Cauchy's Theorem and path independence, Morera's Theorem, and some convergence theorems of the Weierstrass type. Domains are simply connected.

THEOREM 6. If f ϵ (D,g) and γ is a simple closed curve homologous to 0 in D then g f = 0.

PROOF. Using the polar form of Green's Theorem, re g[f] and im g[f] each reduce to zero after substitution of the generalized Cauchy Riemann conditions (2.4).

The stronger form of Cauchy's Theorem, allowing exceptional points in the domain, is developed in [16], p. 62-66.

COROLLARY 1. When $f \in (D,g)$, then g f is independent of the path joining a and b in D.

PROOF. If two paths form a to b in D do not cross or cross a finite number of times, the result follows by Theorem 6 and the definitions and operational properties of the path integrals. If the paths cross infinitely often a limiting process is available. (See [13], p. 315).

THEOREM 7. Let $f \in (D,g)$ and z_0 be fixed in D, and define $F = \int_{z_0}^{g} f$; then $F \in (D,g)$ and further $F'_g = ((exp \int_{z_0}^{r} dr/g)/g) f$. (4.6)

PROOF. Since the generalized integral is path independent we apply properties of line integrals in the plane to compute the partial derivatives of the real and the imaginary parts of the integral function F. System (2.4) is satisfied, so the derivative function is given by (2.3) as

$$F'_{g} = e^{-i\theta} \left(\frac{g}{z} \int_{0}^{z} f \right)_{r}$$
 which is equivalent to (4.6).

We thus demonstrate for the generalized case the differentiability of the integral. The analytic case $g(r) \equiv r$ is seen by (4.6) as necessary (as well as sufficient) that $F'_g \equiv f$.

THEOREM 8. Let $f \in C^1$ in D and g satisfy Definition 1. If g = 0 for every simple closed curve γ in D, then f is g-analytic in D.

¹ PROOF. In (2.5) both the real and imaginary parts of the generalized integral are represented by real line integrals $\int_{\gamma} (P \, dr + Q \, d\theta)$ where P and Q are both in C^1 . Since by the hypothesis we have independence of path for these integrals, $P_{\theta} = Q_r$, or:

Algebraic manipulations of this system show (2.4) for f = u+iv.

Before showing some Weirstrass-type convergence results, we need a bounding relation on the generalize integral which depends on inequalities for real line integrals.

LEMMA 2. When γ is rectifiable

THEOREM 9. If f_n is continuous on regular arc γ for each n, and the sequence $\{f_n\}$ converges uniformly to f on γ then

PROOF. Since f is continuous there is an N such that for n > N

THEOREM 10. If for all n, $f_n \in C^2$ is g-analytic on open set A and $\{f_n\}$ converges uniformly to f on compact subsets of A, then f is g-analytic on A. PROOF. For $z \in A$ there is a disk containing z with its closure in A. We

show $f \in (D,g)$ on such disks, hence f is g-analytic for $z \in A$. Let Y be any simple closed curve in a disk contained in A. Then $gf_n = 0$ for each n by Theorem 6. By Theorem 9, gf = 0 hence Theorem 8 gives g-analyticity in the disk.

COROLLARY 2. If to the hypothesis of Theorem 10 is added, for $f_n = u_n + iv_n$ that $\{u_n\}$ converges uniformly to u and $\{v_n\}$ converges uniformly to v where f = u+iv, then $f'_g = \lim_{n \to \infty} (f_n)'_g$.

PROOF. We now have $\lim_{n\to\infty} (u_n)_r$ and $\lim_{n\to\infty} (v_n)_r = v_r$ hence there is an N such that for n > N

$$\left|\left(f_{n}\right)_{g}^{\prime}-f_{g}^{\prime}\right|=\left|e^{-i\theta}\left(\left(\left(u_{n}\right)_{r}+i\right)v_{n}\right)_{r}\right)-\left(u_{r}+iv_{r}\right)\right)\right|<\varepsilon$$

A version of the argument principle and of Cauchy's Integral Formula are available from the theory of Beltrami's equation. For completeness we show the latter for g-analytic functions.

THEOREM 11. If f $_{\varepsilon}$ (D,g) and γ is a simple closed curve homologous to 0 in D, and z is in the interior of γ , then

$$f(z_{o}) = \frac{1}{2\pi i} \int_{\gamma} \frac{f(z)dz}{z-z_{o}} + \frac{1}{2\pi} \iint_{Int\gamma} \frac{(g-r) e^{i2\theta} f'_{g}(z)drd\theta}{z-z_{o}} .$$

See [5], p. 24-25 and p. 91 for discussion of more general cases.

5. APPLICATIONS

One interesting example of a g-analytic function with domain $-\{(0,0)\}$ and locally quasiconformal with continuous extension at the isolated boundary point (0,0), and K-quasiconformal on bounded sets, maps the finite plane onto a fixed open disc.

EXAMPLE 3. For fixed ρ , real and such that $0 < \rho < \infty$, define

$$f(z) = \begin{cases} (2\rho e^{i\theta} tan^{-1}r)/\pi, \ z \neq 0, \\ 0, \ z = 0. \end{cases}$$

The function satisfies (2.2) for $g = (1+r^2)tan^{-1}r$ and maps the finite plane onto the open disc $|f(z)| < \rho$.

Concentric annuli may be g-conformally mapped whatever the proportions of their radii.

EXAMPLE 4. For annuli: $A_1 = 0 < r_1 < |z| < r_2 < \infty$,

$$A_2 = 0 < R_1 < |z| < R_2 < \infty$$
,

let

$$f(z) = e^{i\theta}(R_2(r-r_1)-R_1(r-r_2))/(r_2-r_1)$$
.

Then $f:A_1 \longrightarrow A_2$ homeomorphically and f is g-analytic for $g = r + ((R_1r_2-R_2r_1)/(R_2-R_1))$.

The convergence properties of the g-integral allow a comparison to the general quasiconformal situation. When the generalized functions satisfying the Beltrami equation (2.2) are quasiconformal in a domain (see Section 3), they are of the type called regular quasiconformal. Although the uniform convergence of a sequence of K-

quasiconformal mappings to a homeomorphism implies that the limit mapping is also Kquasiconformal, in the case of a sequence of regular K-quasiconformal mappings the limit mapping need not be regular. (See [8], p. 17-19.) For g-analytic regular Kquasiconformal functions, the limit mapping is g-analytic.

COROLLARY 3. A Beltrami algebra (D,g) is uniformly closed.
