### A new invariant on hyperbolic Dehn surgery space

**Abstract** In this paper we de ne a new invariant of the incomplete hyperbolic structures on a 1-cusped nite volume hyperbolic 3-manifold M, called the ortholength invariant. We show that away from a (possibly empty) subvariety of excluded values this invariant both locally parameterises equivalence classes of hyperbolic structures and is a complete invariant of the Dehn llings of M which admit a hyperbolic structure. We also give an explicit formula for the ortholength invariant in terms of the traces of the holonomies of certain loops in M. Conjecturally this new invariant is intimately related to the boundary of the hyperbolic Dehn surgery space of M.

### 1 Introduction

Let M be an orientable 3-manifold which admits a complete, nite-volume hyperbolic structure with a single cusp. Thurston's hyperbolic Dehn surgery theorem applied to M says that all but a nite number of topological Dehn Ilings on M have hyperbolic structures. To prove this, Thurston introduced the deformation space H(M) of incomplete hyperbolic structures on M whose completions have 'Dehn surgery-type' singularities (see [25]). This space includes any hyperbolic cone-manifold whose set of non-singular points is di eomorphic to M. The space H(M) is of continuing interest because it o ers a possible approach (due to Thurston) to the Geometrization Conjecture. In particular, non-hyperbolic geometric structures and topological decompositions along incompressible spheres and tori can often be produced by understanding the ways that hyperbolic structures can degenerate near the boundary of H(M) (see Thurston [25, Chapter 4], Kerckho [18] and Kojima [20]). This approach has recently yielded a proof of the Orbifold Theorem (see Cooper-Hodgson-Kerckho [6, Chapter 7] or Boileau-Porti [2]).

In this paper we introduce a  $\mathbb{C}^n$ -valued invariant  $Orth_K$  of each incomplete hyperbolic structure in H(M), called the *ortholength invariant*. This invariant is de ned in terms of a topological ideal triangulation K of M, but it is actually independent of K in the sense that for 'generic' K,  $Orth_K$  determines the ortholength invariant corresponding to any other ideal triangulation (see Theorem 17). The main result of this paper says that away from a (possibly empty) subvariety of values, the ortholength invariant locally parameterises H(M) and it is a complete invariant of the (topological) Dehn llings of M which admit a hyperbolic structure (see Theorem 18).

For a hyperbolic structure whose metric completion is a cone-manifold, the ortholength invariant is essentially a list of hyperbolic cosines of the complex distances<sup>1</sup> from the cone-manifold's singular set to itself along the edges<sup>2</sup> of K. Hence there is a close connection between the ortholength invariant and the *tube radius* of a hyperbolic Dehn lling, i.e. the supremum of the radii of the embedded hyperbolic tubes in M about the singular set of the Dehn lling.

The importance of the tube radius has emerged recently from the work of Kojima [19] and Hodgson-Kerckho [18], [17]. In these papers, the condition that the tube radius stays bounded away from zero as cone-angles are varied has emerged as the key to ensuring that the hyperbolic structures do not degenerate. (By contrast, it is possible for hyperbolic cone-manifolds to degenerate while their volume remains bounded above zero, e.g. see [19], especially Theorem 7.1.2 or the example of  $\chi$ 7.2.) This suggests a relationship between the boundary of H(M) and the ortholength invariant which deserves further study (see Conjecture 20).

The terminology 'ortholength invariant' follows [21], where Meyerho de nes the complex ortholength spectrum of a closed hyperbolic 3-manifold as the set of complex distances between pairs of the manifold's simple closed geodesics. He shows that the ortholength spectrum plus some combinatorial data determines the manifold up to isometry. Hence the fact that  $Orth_{\mathcal{K}}$  is a complete invariant of the topological Dehn llings of M which admit a hyperbolic structure can be interpreted as a strengthened version of Meyerho 's result, namely that a nite (and computable) subset of the ortholength spectrum plus slightly stronger combinatorial information than assumed in [21] determines the lled manifold up to isometry.

The rest of this paper is set out as follows. In Section 2 we show that it is possible to parameterise a conguration of lines in  $\mathbb{H}^3$  in terms of the complex distances between them. In Section 3 we de ne the ortholength invariant and give a formula for it in terms of the traces of the holonomies of certain loops in M, thereby showing that  $Orth_K$  is a rational map from the  $PSL_2\mathbb{C}$ -character variety X(M) of M into  $\mathbb{C}^n$ . The main section of this paper is Section 4, where we prove that the ortholongth invariant locally parameterises incomplete hyperbolic structures on M and is a complete invariant when restricted to the (topological) Dehn llings of M which admit a hyperbolic structure (for those hyperbolic structures whose ortholength invariant does not lie in a certain subvariety). We also prove (under a weak technical assumption) that the ortholength invariant is a birational equivalence from certain interesting irreducible components of X(M) to certain irreducible components of a complex a ne algebraic variety P(K) $\mathbb{C}^n$ . In Section 5 we calculate the orthologith invariant when M is the gure-8 knot complement. Section 6 concludes this paper with a conjecture and a discussion of some applications for the orthologeth invariant, including the construction of incomplete hyperbolic structures on M.

This paper is based on my doctoral thesis and I would like to acknowledge and thank my advisor Craig D. Hodgson for his guidance throughout the work presented here.

## 2 Con gurations of lines in hyperbolic 3-space

We say that n oriented lines  $I_1, \ldots, I_n$  in hyperbolic 3-space  $\mathbb{H}^3$  realise a set of complex numbers  $x_{ij} \ 2 \ \mathbb{C}$   $(i;j=1;\ldots;n)$  if cosh of the complex distance<sup>3</sup> between each pair of lines  $I_i$  and  $I_j$  is equal to  $x_{ij}$ . This section is motivated by the following question.

**Problem 1** When is it possible to realise a given set of complex numbers  $x_{ij} \ 2\mathbb{C} \ (i;j=1;\ldots;n)$  by an arrangement of lines and how unique is such an arrangement?

A complete answer to Problem 1 is given in Theorem 7. A corollary to this theorem (Corollary 8) says that there exists an arrangement of four lines which realises a set of complex numbers  $x_{ij}$   $2 \mathbb{C}$   $(i;j=1;\ldots;4)$  if and only if these complex numbers satisfy a 'hextet' equation. This corollary is the key result

which allows us to locally parameterise hyperbolic structures on a 3-manifold by 'ortholengths' (see Section 4). The results of this section prior to Problem 4 are simply re-statements of some of the ideas Fenchel presented in [10]. For related material see Thurston [27, xx2.3-2.6].

The end-points of a line in  $\mathbb{H}^3$  are two distinct points on the sphere at in nity  $\mathbb{S}^2_7$ , and conversely any two such points determine a line. We identify the set of *oriented lines* in  $\mathbb{H}^3$  with  $\mathbb{S}^2_7$   $\mathbb{S}^2_7$  n where = f(x;x)  $j \times 2$   $\mathbb{S}^2_7$  g, and we refer to an element of  $\mathbb{S}^2_7$   $\mathbb{S}^2_7$  n as the *ordered end-points* of an oriented line in  $\mathbb{H}^3$ .

A simple calculation shows that every traceless matrix  $A \ 2 \ \mathrm{SL}_2\mathbb{C}$  has eigenvalues i. The eigenvectors of A correspond to points on the sphere at in nity  $\mathbb{S}^2_7$  which are xed by the action<sup>4</sup> of A. Hence there is an oriented line corresponding to A whose ordered end-points are  $(p;q) \ 2 \ \mathbb{S}^2_7 \ \mathbb{S}^2_7 \ n$ , where p corresponds to eigenvalue -i and q corresponds to eigenvalue i. It is not hard to check that the map  $A \ \mathbb{F}(p;q)$  is a homeomorphism from

$$SL \stackrel{\text{def}}{=} fl \ 2 \ SL_2 \mathbb{C} \ j \ \text{tr} \ l = 0g$$

to the space of oriented lines in  $\mathbb{H}^3$ . We identify these two spaces and from now on we will use the same symbol to denote both an oriented line and the corresponding element of SL.

Note that as a consequence of this, -12 SL denotes the same line in  $\mathbb{H}^3$  as 12 SL but with the opposite orientation.

Now,  $PSL_2\mathbb{C}$  acts by orientation-preserving isometries on the set of oriented lines in  $\mathbb{H}^3$ . Under the correspondence between oriented lines and SL, this gives us a corresponding action of  $PSL_2\mathbb{C}$  on SL, given by  $g \mid = g \mid g^{-1}$  for any  $g \mid PSL_2\mathbb{C}$  and  $i \mid 2SL$ , where  $g \mid 2SL_2\mathbb{C}$  is either of the matrices covering g. Hence studying the geometric properties of arrangements of lines in  $\mathbb{H}^3$  is the same as studying the properties of subsets of SL which are invariant under the conjugacy action of  $SL_2\mathbb{C}$ .

Given two oriented lines  $l; m \ 2 \ SL$ , an obvious conjugacy invariant of the pair is tr(lm). Lemma 3 (below) says that this invariant is essentially cosh of the complex distance between l and m. However, before stating this lemma we introduce some notation<sup>5</sup>.

**De nition 2** *Line Matrices* The complex vector space *L* of *line matrices* consists of all 2 2 complex matrices with zero trace. This space is endowed with a symmetric bilinear form < ; > given by

$$\langle I; m \rangle = -\frac{1}{2} \operatorname{tr}(Im)$$

for any l; m 2 L.

It is not hard to check that the bilinear form <; > is non-degenerate on L. Also, each non-singular line matrix I Z L acts on  $\mathbb{H}^3$  as a half-turn about some line so there is an (unoriented) line associated with each non-singular line matrix. This is where the terminology 'line matrices' comes from.

Lemma 3 For any I; m 2 SL,

$$\langle I; m \rangle = \cosh(\mathcal{O}_{\mathbb{C}}(I; m)) \tag{1}$$

where  $d_{\mathbb{C}}(I; m)$  is the complex distance between I and m.

**Proof** See Fenchel [10, xV.3].

Alternatively, the reader can take Lemma 3 as the de nition of the complex distance between two oriented lines in  $\mathbb{H}^3$ .

Note that  $\langle l; l \rangle = \det l$  for any  $l \ 2 \ L$  so  $SL = fl \ 2 \ L \ j \ \langle l; l \rangle = 1g$  is the set of normalised line matrices. Then by Lemma 3 we can rephrase Problem 1 in terms of linear algebra as follows.

**Problem 4** Given some complex numbers  $x_{ij} \ 2 \ \mathbb{C} \ (i;j=1;...;n)$  so that  $x_{ij} = x_{ji}$  and  $x_{ii} = 1$ , do there exist oriented lines  $I_1, ..., I_n \ 2 \ \text{S} L$  so that

$$< I_i; I_i > = x_{ij}$$
?

To what extent do these conditions determine the lines  $l_1, \ldots, l_n$  if they exist?

Now, the action of  $PSL_2\mathbb{C}$  on SL extends to an action on L in an obvious way<sup>6</sup> and clearly <; > is invariant under this action. Also note that <; > is invariant under the map L! L given by I? -I. The following lemma says that these are the only isomorphisms of (L; <; >).

**Lemma 5** For each linear map : L ! L which preserves < ; > there is some element  $g \ 2 \ PSL_2\mathbb{C}$  and some choice 1 of sign so that

$$(I) = g I$$

for any 12 L.




Figure 1: The two orientation-classes of orthogonal frames

**Proof** Consider three lines  $l_1; l_2; l_3 \in SL$  for which  $\langle l_i; l_j \rangle = 0$  for each  $i \notin j$ . By Lemma 3, these lines all meet at a common point of  $\mathbb{H}^3$  where they are mutually perpendicular. We assume that the orientations of the  $l_i$  have been chosen so that they de ne a right-handed frame at this common point (see Figure 1).

Now, if : L ! L preserves <; > then <  $(I_i)$ ;  $(I_j)$  > = 0 for each  $i \not = j$  and so by Lemma 3,  $(I_1)$ ;  $(I_2)$ ;  $(I_3)$  are also mutually perpendicular lines which meet at a common point. By replacing by - if need be we can assume  $(I_1)$ ;  $(I_2)$ ;  $(I_3)$  de ne a right-handed frame. Since  $PSL_2\mathbb{C}$  acts transitively on the bundle of right-handed orthogonal frames of  $\mathbb{H}^3$  (see [27, x2.2]) there is an isometry  $g \supseteq PSL_2\mathbb{C}$  which takes  $I_i$  to  $(I_i)$  for each i = 1, 2, 3. Hence  $(I_i) = g \mid I_i$  for each i = 1, 2, 3. Since the  $I_i$  form a basis for L (linear dependence would imply that  $< I_i$ ;  $I_i > = 0$  for some i) this proves the lemma.  $\square$ 

In fact, from this proof it is clear that the action of  $PSL_2\mathbb{C}$  f 1g on L induces an isomorphism from  $PSL_2\mathbb{C}$  f 1g to the group  $O_3(\mathbb{C})$  of isomorphisms of (L; <; >) (see also Footnote 5, above). Note that -1 acts on L by simultaneously reversing the orientations of all lines and is not related to the orientation-reversing isometries of  $\mathbb{H}^3$ .

Let (V;g) denote a nite-dimensional complex vector space V equipped with a symmetric, bilinear form g. Then associated to g there is a map  $V \not V$  from V to its dual given by  $V \not V g(V; )$ . The rank of g (denoted rank(g)) is the dimension of the image of this map and g is non-degenerate if this map is an isomorphism. To solve Problem 4 we will use the following lemma from linear algebra.

**Lemma 6** Let (V;g) and (W;h) be two nite-dimensional complex vector spaces equipped with symmetric, bilinear forms g and h. If rank(g) rank(h) then there exists a linear transformation :V! W so that

$$h = g$$

i.e. so that g(x; y) = h(x; y) for any  $x; y \ge V$ . Furthermore, if h is non-degenerate and rank(g) = rank(h) or rank(g) = rank(h) - 1 then is unique up to composing it on the left with an isomorphism of (W; h).

**Proof** This is an elementary consequence of the fact that (V;g) is isomorphic to  $(\mathbb{C}^n; E_r)$  for  $n = \dim(V)$  and r = rank(g), where  $E_r$  is the bilinear form de ned by  $E_r(u; v) = u^T G v$  for any  $u; v \in \mathbb{C}^n$  and G is the n n diagonal matrix  $\operatorname{diag}(1; \dots; 1; 0; \dots; 0)$  with r non-zero entries.

Armed with Lemmas 5 and 6 we can now completely solve Problem 4.

**Theorem 7** For i;j = 1; ...; n let  $x_{ij} \ 2 \mathbb{C}$  be given complex numbers so that  $x_{ij} = x_{ji}$  and  $x_{ii} = 1$ . Then there exist  $l_1; ...; l_n \ 2 \ SL$  for which  $\langle l_i; l_j \rangle = x_{ij}$  if and only if rank(X) 3, where X is the n n matrix whose  $(i;j)^{th}$  entry is  $x_{ij}$ . If some  $x_{ij} \ne 1$  then the arrangement of lines  $l_1; ...; l_n$  is unique up to the action of  $PSL_2\mathbb{C}$  f 1g, i.e. unique up to orientation-preserving isometry and simultaneous reversal of orientations.

If all  $x_{ij} = 1$  then there may be non-isometric arrangements of lines which realise the  $x_{ij}$ .

**Proof of Theorem 7** Let  $x_{ij} \ 2 \ \mathbb{C}$  be given complex numbers and suppose that there exist lines  $I_1; \ldots; I_n \ 2 \ \mathrm{SL}$  so that  $x_{ij} = \langle I_i; I_j \rangle$ . Then since L is 3-dimensional, any four of the lines must be linearly dependent. From this it follows that any four rows of X are linearly dependent. For example, there exist non-zero constants  $X_1; \ldots; X_n \ 2 \ \mathbb{C}$  so that  $X_n \ 1/1 + \ldots + X_n \ 1/1 + \ldots + X$ 

$$_{1} < l_{1}; l_{i} > + ::: + _{4} < l_{4}; l_{i} > = 0$$

(i.e.  $_1x_{1i} + \cdots + _4x_{4i} = 0$ ) for each  $i = 1, \dots, n$ . Hence rank(X) = 3.

So now suppose that for i:j=1; ...; n we have  $x_{ij} \ge \mathbb{C}$  so that  $x_{ij}=x_{ji}$  and  $x_{ii}=1$  and that rank(X)=3 where  $X=[x_{ij}]$  is the matrix de ned in the statement. De ne a symmetric, bilinear form g on  $\mathbb{C}^n$  by

$$g(x; y) = x^{\mathrm{T}} X y$$

for any  $x,y \in \mathbb{C}^n$ . Then rank(g) = rank(<;>) so setting  $(V;g) = (\mathbb{C}^n;g)$  and (W;h) = (L;<;>) in Lemma 6 gives us a linear map  $\mathbb{C}^n : L$  so that (Z; Z) = g. For each (Z; Z) = g where (Z; Z) = g is the standard basis for  $(Z)^n$ . Then

$$X_{ij} = e_i^T X e_i = g(e_i; e_i) = \langle e_i; e_i \rangle = \langle I_i; I_i \rangle$$

for any i; j = 1; ...; n. Note that  $\langle l_i; l_i \rangle = x_{ii} = 1$  for each i = 1; ...; n so  $l_i \geq SL$ , i.e. each  $l_i$  corresponds to an oriented line in  $\mathbb{H}^3$ .

Now, if some  $x_{ij} \neq 1$  then rank(g) = 2 or 3 (this uses the fact that X is symmetric and  $x_{ii} = 1$ ). Hence by Lemma 6, (and hence the arrangement of lines  $l_1::::;l_n$ ) is unique up to composing by an isomorphism of (L;<;>). But by Lemma 5 the isomorphisms of (L;<;>) are exactly given by the action of  $PSL_2\mathbb{C}$  f 1g on L. Hence the arrangement of lines  $l_1::::;l_n$  is unique up to orientation-preserving isometry and simultaneous reversal of orientations.  $\square$




Figure 2: Arrangements of (a) three lines and (b) four lines

The special cases of Theorem 7 when n=3 and n=4 are of particular interest to us. If three lines  $l_1/l_2/l_3$  2 SL all have distinct end-points on  $\mathbb{S}^2_7$  then any two of these lines has a common-perpendicular. Adding these three perpendiculars and truncating appropriately gives an arrangement of six line segments in  $\mathbb{H}^3$  which meet at right-angles, i.e. a right-angled hexagon (see Figure 2(a)). Motivated by this generic case we will simply say that any three oriented lines de ne a right-angled hexagon, without making the assumption that the lines have distinct end-points. Then Theorem 7 applied to  $l_1/l_2/l_3$  gives the well-known result that the complex distances along alternating edges of a right-angled hexagon determine the hexagon up to isometry (see [10, xVI.4]).

Similarly, any four lines  $l_1, \ldots, l_4$  2 SL which all have distinct end-points on  $\mathbb{S}^2_7$  have six pair-wise common-perpendiculars. Adding these perpendiculars and truncating all lines appropriately gives an arrangement of lines in  $\mathbb{H}^3$  loosely resembling a tetrahedron (see Figure 2(b)). Since this arrangement is like a tetrahedron whose vertices have been stretched into the lines  $l_1, \ldots, l_4$ , turning its faces into right-angled hexagons, we call such an arrangement a *hextet*. As with right-angled hexagons, we will drop the requirement that the end-points of  $l_1, \ldots, l_4$  be distinct and simply say that any four oriented lines in  $\mathbb{H}^3$  de ne a hextet. Substituting n=4 into Theorem 7 gives the following corollary.

**Corollary 8** (Existence and Rigidity of Hextets) Let  $x_{ij} \ge \mathbb{C}$  be given complex numbers for  $i; j = 1; \ldots; 4$  so that  $x_{ij} = x_{ji}$ ,  $x_{ii} = 1$ . Then there exist  $l_1; \ldots; l_4 \ge SL$  so that  $\langle l_i; l_j \rangle = x_{ij}$  if and only if the  $x_{ij}$  satisfy the hextet equation

If some  $x_{ij} \neq 1$  then these lines  $l_1 \neq l_4$  are unique up to orientation-preserving isometry and simultaneous reversal of each line's orientation.

It was known to Fenchel (see [10, xV.3]) that if four lines  $l_1; ...; l_4 \ 2 \ SL$  are given then the complex numbers  $< l_i; l_i >$  satisfy the above hextet equation.

We nish this section with a brief discussion of degenerate arrangements of lines in  $\mathbb{H}^3$ .

**De nition 9** An arrangement of lines  $l_1; ...; l_n$  2 SL is *non-degenerate* if  $l_1; ...; l_n$  spans L and the arrangement is *degenerate* otherwise.

The following lemma gives us three more characterisations of degeneracy.

**Lemma 10** Let  $l_1; \ldots; l_n \geq SL$  be given, let  $x_{ij} = \langle l_i; l_j \rangle$  for each  $i; j = 1; \ldots; n$  and let X be the n n matrix whose  $(i; j)^{th}$  entry is  $x_{ij}$ . If some  $x_{ij} \neq 1$  then the following are equivalent:

- (1)  $l_1$ ; ...;  $l_n$  is a degenerate arrangement of lines.
- (2)  $l_1, \ldots, l_n$  have a common perpendicular line.
- (3) There exists an orientation-preserving isometry taking the arrangement  $l_1; ...; l_n$  to the arrangement  $-l_1; ...; -l_n$ .
- (4) rank(X) = 2.
- **Proof (1)** *)* **(2)** Suppose that  $l_1; \ldots; l_n$  are linearly dependent. Some  $x_{ij} \not\in 1$  so without loss of generality we assume  $x_{12} \not\in 1$  and hence that  $l_1$  and  $l_2$  have no end-points in common. Therefore  $l_1$  and  $l_2$  are linearly independent and they also have a common perpendicular  $n \in 2$  SL (whose orientation is not unique). Then for each  $i = 3; \ldots; n$  there exist  $l_1; l_2 \in 2$  C so that  $l_i = l_1 + l_2 + l_2$ . But  $l_1; l_2 \in 2$  Such that  $l_3; l_4 \in 2$  But  $l_4; l_5 \in 2$  Such that  $l_6 \in 2$  and so  $l_6; l_7 \in 2$  and hence  $l_6$  is also perpendicular to  $l_7$  (by Lemma 3).
- (2) ) (3) If  $l_i \ 2 \ SL$  is perpendicular to  $n \ 2 \ SL$  then the half-turn about n takes  $l_i$  to  $-l_i$ .
- (3) ) (1) Suppose there is some  $g ext{ 2 PSL}_2\mathbb{C}$  so that  $g ext{ } l_i = -l_i$  for each  $i = 1; \ldots; n$ . If  $l_1; \ldots; l_n$  span L then g is an isometry which takes every oriented line to the same line but with the opposite orientation, which is absurd.
- **(1) (4)** If we assume that any three of the lines  $I_1$ ; ...,  $I_n$  are linearly dependent then it follows that any three of the rows of X are linearly dependent, too, and hence that rank(X) < 3. For example, if  $I_1 I_1 + I_2 I_2 I_3 I_3 = 0$  then

for each i = 1; ...; n. But since some  $x_{ij} \ne 1$ ,  $rank(X) \ne 1$  and so rank(X) = 2.

**(4)** ) **(1)** Conversely, suppose that rank(X) = 2 and assume (in order to derive a contradiction) that the  $l_1; \ldots; l_n$  span L. Without loss of generality assume that  $l_1; l_2; l_3$  form a basis for L. Then since rank(X) = 2, the rst three rows of X are linearly dependent so there exist  $l_1; l_2; l_3 \in \mathbb{R}$  so that

for each i=1; ...; n. But since <; > is non-degenerate and (by assumption)  $I_1$ ; ...;  $I_n$  span L, this implies  ${}_1I_1 + {}_2I_2 + {}_3I_3 = 0$  which is a contradiction.  $\square$ 

### 3 The ortholength invariant

In this section we de ne the ortholongth invariant of each incomplete hyperbolic structure in the hyperbolic Dehn surgery space H(M) of M. This invariant is given purely in terms of holonomy representations so its de nition naturally extends to a map  $Orth_K: X(M) \dashrightarrow \mathbb{C}^n$  from the  $PSL_2\mathbb{C}$ -character variety X(M) of M to  $\mathbb{C}^n$ . We show that  $Orth_K$  is a rational map whose image lies inside a variety  $P(K) = \mathbb{C}^n$ . For examples of  $Orth_K$ , P(K) and X(M), see Section 5.

Let M be an oriented, nite volume, 1-cusped hyperbolic 3-manifold (as in Section 1) and let N be an embedded horoball neighbourhood of the cusp. Then N is di eomorphic to the product of a 2-torus  $T^2$  with the half-open interval [0;1) and furthermore the complement in M of the interior of N is a compact 3-manifold with boundary  $@N = T^2$  (e.g. see Thurston  $[27, \times 4.5]$ ). Let K be a (topological) ideal triangulation of M (see Benedetti-Petronio  $[1, \times E.5-i]$ ) which meets N 'nicely', i.e. so that inside any tetrahedron A of K, N has four connected components, each being a punctured neighbourhood of one of the vertices of A. Let be a base-point for M which lies in @N.

Now, let :  $_1(\mathcal{M};)$  !  $PSL_2\mathbb{C}$  be a homomorphism which satis es the condition that  $(_1(@N;))$  xes exactly two points on the sphere at in nity  $\mathbb{S}^2_{7}$  (e.g. could be the holonomy representation of an incomplete hyperbolic structure of  $H(\mathcal{M})$ ). A simple investigation of the xed-points of the Abelian group  $(_1(@N;))$  shows that this condition is equivalent to the requirement that  $(_1(@N;))$  is a non-trivial group of non-parabolic isometries which is not isomorphic to  $\mathbb{Z}=2$   $\mathbb{Z}=2$  (where  $\mathbb{Z}=2$  is the group with two elements). These conditions in turn are equivalent to the algebraic conditions that

neither

where m and l are any pair of generators of  $_1(@N; ) = \mathbb{Z} - \mathbb{Z}$ .

Now, by our assumption that satis es the conditions (2), it follows that the group ( $_1(@N;)$ ) xes a unique line in  $\mathbb{H}^3$ . Choose an orientation and call the resulting oriented line . Let :  $\widehat{M}$  ! M be the universal cover of M and choose some base-point  $\sim 2^{-1}($ ). This choice allows us to identify the deck-transformations of :  $\widehat{M}$  ! M with  $_1(M;)$ . Let  $\widehat{M}$  be the connected component of  $^{-1}(N)$  which contains  $\sim$ .

<sup>&</sup>lt;sup>7</sup>An orientation-preserving isometry  $g \ 2 \ \text{PSL}_2 \mathbb{C}$  is parabolic if  $g \ne 1$  and  $\text{tr}^2 g = 4$ .

Let  $e_1; \dots; e_n$  be the edges of K and for each  $i = 1; \dots; n$  choose a lift  $e_i$  of edge  $e_i$  in  $\widehat{M}$ . To each end of  $e_i$  there is a corresponding connected component of  $^{-1}(N)$ . Denote these connected components by  $\widehat{N}_1$  and  $\widehat{N}_2$  (note that it is possible that  $\widehat{N}_1 = \widehat{N}_2$  if  $e_i$  is homotopically trivial). Then since  $\widehat{N}_1$  and  $\widehat{N}_2$  both cover N, there exist deck-transformations  $_1$  and  $_2$  for which  $_i(\widehat{N}) = \widehat{N}_i$  (for each i = 1; 2). We de ne the *ortholength*  $d_i$  corresponding to edge  $e_i$  to be

$$d_i \stackrel{\text{def}}{=} d_{\mathbb{C}}(\ (\ _1) \quad ; \ (\ _2) \quad )$$

i.e. de ne  $d_i$  to be the complex distance between  $(\ _1)$  and  $(\ _2)$ . While  $\ _1$  and  $\ _2$  are not unique,  $(\ _1)$  and  $(\ _2)$  do not depend on their arbitrariness and so are well-de ned oriented lines in  $\mathbb{H}^3$ . Also, the de nition of  $d_i$  doesn't depend on our choice of lift  $e_i$  of edge  $e_i$ . This is because any other lift is of the form  $e_i$  for some deck-transformation . In the above prescription this has the e ect of replacing  $\mathcal{N}_i$  by  $(\mathcal{N}_i)$ , i.e. replacing  $e_i$  by  $e_i$  ( $e_i$  = 1/2). But since  $e_i$  ( $e_i$  ) ( $e_i$  ) ( $e_i$  )  $e_i$  is not a ected by this change.

Also, conjugating by some  $g \ 2 \ \mathrm{PSL}_2\mathbb{C}$  has the e ect of replacing by g and each  $(\ _1)$  by  $g \ (\ _1)g^{-1}$ , which clearly leaves  $d_i$  unchanged. This shows that  $d_i$  is independent of our choice of  $\sim$  (which we used to identify  $\ _1(M;\ )$  with the deck-transformations of  $M \ ! \ M$ ) and also that  $d_i$  only depends on the conjugacy class of  $\ .$  We de ne the ortholongth invariant  $Orth_K(\ )$  with respect to the ideal triangulation K evaluated at  $\$  to be

$$Orth_K() \stackrel{\text{def}}{=} (\cosh d_1 : : : : \cosh d_n) \ 2 \mathbb{C}^n$$
:

We think of  $Orth_K()$  as the function which associates cosh of the orthologyth  $d_i$  to edge  $e_i$  of K for each  $i = 1 \neq i \neq n$ .

Now, as noted in Footnote 5 (and see also [3])  $PSL_2\mathbb{C}$  is naturally isomorphic to  $SO_3\mathbb{C}$  and so the space of representations R(M) of  $_1(M)$  into  $PSL_2\mathbb{C}$  is a complex algebraic variety. The  $PSL_2\mathbb{C}$ -character variety X(M) of M is the 'quotient' (in the sense of algebraic geometry, see [3, xx3,4]) of R(M) by the conjugacy action of  $PSL_2\mathbb{C}$ . This space X(M) has a natural algebraic structure which makes it an an ealgebraic variety whose co-ordinate ring is the ring of regular functions on R(M) which are invariant under the  $PSL_2\mathbb{C}$ -conjugacy action.

As noted above,  $Orth_K()$  is de ned on all representations satisfying the conditions (2) and  $Orth_K()$  is constant on conjugacy classes. Hence  $Orth_K()$ 

descends<sup>8</sup> to a function de ned on the complement of a proper<sup>9</sup> sub-variety of X(M). We denote this function by  $Orth_K$  as well, and we write  $Orth_K$ :  $X(M) \longrightarrow \mathbb{C}^n$  to indicate that  $Orth_K$  is not necessarily de ned<sup>10</sup> as a settheoretic function at all points of X(M).

Now, given a tetrahedron  $\mathcal{A}$  of  $\mathcal{K}$ , choose some tetrahedron  $\mathcal{A}$  in  $\widehat{\mathcal{M}}$  which covers it. Each corner of  $\mathcal{A}$  meets a unique connected component of  $\mathcal{A}$  and these connected components determine four (not necessarily distinct) oriented lines (1)

**De nition 11** The Ortholength Space P(K) The ortholength space P(K)  $\mathbb{C}^n$  corresponding to a (topological) ideal triangulation K of M with n edges is the complex annealgebraic variety consisting of those points of  $\mathbb{C}^n$  which satisfy the hextet equations of all the tetrahedra of K. Here the hextet equation of a tetrahedron A of K is

$$0 = \det \begin{pmatrix} 2 & & & & & 3 \\ 1 & x_{12} & x_{13} & x_{14} & 7 \\ 2 & x_{21} & 1 & x_{23} & x_{24} & 7 \\ 2 & x_{31} & x_{32} & 1 & x_{34} & 5 \\ 2 & x_{41} & x_{42} & x_{43} & 1 \end{pmatrix}$$

where the vertices of  $\mathcal{A}$  have been numbered arbitrarily from 1 to 4 and where we denote cosh of the ortholongth associated to the edge of  $\mathcal{A}$  between vertices i and j by  $x_{ij} = x_{j\,i}$ .

<sup>&</sup>lt;sup>8</sup>Since X(M) is not simply the quotient of the representation variety R(M) of M by the conjugacy action of  $PSL_2\mathbb{C}$  this is not immediately obvious. We need two more facts: (1)  $Orth_K() = (1; \ldots; 1) \ 2 \ \mathbb{C}^n$  whenever is reducible (i.e. whenever  $(\ _1(M); \ ))$  xes a point on the sphere at in nity  $\mathbb{S}^2_7$ ) and (2) if is irreducible and  $\mathbb{F}^3_7 = \mathbb{F}^3_7 = \mathbb{F}^3_7 = \mathbb{F}^3_7$  is irreducible and  $\mathbb{F}^3_7 = \mathbb{F}^3_7 = \mathbb{F}^3_7$

Warning: Since X(M) is not necessarily irreducible it is possible that  $Orth_K$  is not de ned at all on some components of X(M).

Note that the hextet equation of 4 doesn't depend on the arbitrary numbering of its vertices.

Although P(K) lies in an n-dimensional space (one dimension for each edge of K) and is de ned by n hextet equations (one for each tetrahedron of K) for 'generic' K, P(K) has an irreducible component which is a complex curve. This follows from Theorem 17 (below) and from the fact that Dehn surgery space is di eomorphic to  $\mathbb C$  in a neighbourhood of the complete structure (see Thurston [25, x5.5]). Conversely, it should be possible to prove that the irreducible component of X(M) which contains the complete hyperbolic structure is one-dimensional over  $\mathbb C$  via Theorem 17 and a lemma about the dimension of P(K).

We nish this section with an explicit formula for the ortholength invariant. This formula is given in terms of a presentation for  $_1(M;)$  based on the ideal triangulation K of M. The generators for this presentation consist of generators for  $_1(@N;)$  plus loops  $_i \ @\ _1(@N;)$  which lie in  $@N\ [e_i,]$  where  $e_i$  is the  $i^{th}$  edge of K ( $i = 1; \ldots; n$ ).

**Proposition 12** Let :  $_1(M; )$  !  $PSL_2\mathbb{C}$  be a representation on which  $Orth_K$  is de ned (i.e. for which the conditions (2) hold) and for  $i=1;\ldots;n$  let  $h;g_i \ 2\ SL_2\mathbb{C}$  be matrices which cover ( ); (  $_i$ )  $2\ PSL_2\mathbb{C}$ , for  $_i$  as above and some non-trivial  $2\ _1(@N; )$ . Then the  $i^{th}$  co-ordinate  $\cosh d_i$  of  $Orth_K( )$   $2\ P(K)$   $\mathbb{C}^n$  is

$$\cosh d_{i} = 2 \frac{\operatorname{tr}(\hbar g_{i}) \operatorname{tr}(\hbar^{-1} g_{i}) - \operatorname{tr}^{2} g_{i}}{\operatorname{tr}^{2} \hbar - 4} - 1$$

where i = 1 : : : : : n.

Note that  $\operatorname{tr}(\hbar g_i)\operatorname{tr}(\hbar^{-1}g_i)$ ,  $\operatorname{tr}^2g_i$  and  $\operatorname{tr}^2\hbar$  are independent of the choice of matrices  $\hbar$  and  $g_i$  covering (m) and (i) and so these three functions de ne elements of the co-ordinate ring of X(M) (see [3]). Hence from the above formula it is clear that  $\operatorname{Orth}_K: X(M) \dashrightarrow P(K)$  is a rational map.

**Proof of Proposition 12** Suppose we have the set-up as in the statement, and let (1@N;) x a geodesic of  $\mathbb{H}^3$ , which we give an arbitrary orientation. Then  $\cosh d_i$  is equal to  $\cosh(d_{\mathbb{C}}(1;g_i))$ , where  $g_i = (1;1) 2 \operatorname{PSL}_2\mathbb{C}$ . Since  $\cosh(d_{\mathbb{C}}(1;g_i))$  is invariant under conjugating by an orientation-preserving isometry, we can assume

$$h = \begin{array}{ccc} e^{x=2} & 0 \\ 0 & e^{-x=2} \end{array} \quad g_i = \begin{array}{ccc} a & b \\ c & d \end{array} ;$$

(where ad - bc = 1) for the purposes of calculating  $\cosh(d_{\mathbb{C}}(\cdot;g_i))$ ). We'll then express our answer in terms which are invariant under conjugacy, and then our formula will hold true for general  $\hbar$  and  $g_i$ .

The axis of  $\hbar$  has end-points 0 and  $\pi$  on the sphere at in nity, so the line matrix of is  $\begin{bmatrix} i & 0 \\ 0 & -i \end{bmatrix} 2 \operatorname{SL}_2 \mathbb{C}$ . Then by Lemma 3 and the fact that the line matrix of  $g_i$  is  $g_i \begin{bmatrix} i & 0 \\ 0 & -i \end{bmatrix} g_i^{-1}$ , we have

Combining this with

$$\cosh x - 1 = 2 \cosh^2(x=2) - 2 = (\operatorname{tr}^2 h - 4) = 2$$

gives us the required formula for  $\cosh d_i$ .

# 4 Parameterising hyperbolic structures with ortholengths

In this section we prove that the ortholength invariant locally parameterises the deformation space H(M) and is a complete invariant when restricted to the (topological) Dehn llings of M which admit a hyperbolic structure (as long as the hyperbolic structure in question has ortholength invariant not lying in a certain (possibly-empty) subvariety). We also prove (under a weak technical assumption) that the ortholength invariant is a birational equivalence from certain interesting irreducible components of X(M) to certain irreducible components of P(K).

Fix a (topological) ideal triangulation K of M with n edges and let a set of orthological parameters  $p = (p_1, \dots, p_n) \ 2 \ P(K)$  be given. Then a *realisation* of

p is a set of n hextets (see Figure 2(b)) each of which realises the ortholongth parameters associated to the edges of a tetrahedron of K. More precisely, a realisation is an association of an oriented line to the four corners of each tetrahedron  $\mathcal{A}$  of K so that cosh of the complex distance between any pair of these four lines is equal to the ortholongth parameter of the edge of  $\mathcal{A}$  which lies between the corresponding pair of vertices of  $\mathcal{A}$ .

The broad aim of this section is to construct an inverse to  $Orth_K: X(M) \dashrightarrow P(K)$ . To each point  $p \ 2 \ P(K)$ , Corollary 8 guarantees the existence of a realisation of p by hextets. Our strategy for building a representation  $_1(M)$ ? ! PSL $_2\mathbb{C}$  is essentially to glue copies of these hextets together to form a type of skeletal developing map for M whose rigidity then gives us a holonomy representation for free (see the proof of Lemma 14, below). However, this approach is complicated slightly by the fact that the ortholongth parameters  $p = (p_1, \ldots, p_n)$  don't quite determine the hextets up to isometry (see Corollary 8), even if we assume no  $p_i = 1$ . This forces us to make De nition 13, below.

First note that each face F of K is contained in exactly two tetrahedra of K and that these two inclusions composed with the realisation of p by hextets gives two right-angled hexagons corresponding to F. Here we think of a right-angled hexagon corresponding to F as an association of an oriented line to each of the three corners of F, and by an isometry between such hexagons we mean an orientation-preserving isometry which respects this association.

**De nition 13** *Coherence* Let  $p = (p_1; ...; p_n)$  2 P(K) be such that no  $p_i = 1$ . Then a realisation of p by hextets is *coherent* if the pair of right-angled hexagons corresponding to each face of K are isometric. If a coherent realisation of p exists then we say that p is *coherent*.

Note that any pair of right-angled hexagons corresponding to a face of K have the same orthologists and so by Theorem 7 must be either isometric or isometric after reversing the orientations of the lines in one of the hexagons. Also note (from the de nition of orthologist invariant, see Section 3) that any point in the set-theoretical image of  $Orth_K$  is coherent.

Now, since the rigidity of hextets described in Corollary 8 may fail if all of the orthologth parameters are 1, we will usually restrict our attention to  $p \ 2 \ P(K) \ n \ T$ , where

where  $p_i; p_j; p_k$  are the co-ordinates of  $p = (p_1; \dots; p_n)$  corresponding to the edges of  $F_m$ . By Lemma 10,  $S_m$  is the set of orthologiths  $p \ 2 \ P(K)$  so that any realisation of p by hextets has a degenerate hexagon corresponding to face  $F_m$ . De ne

$$S \stackrel{\text{def}}{=} \left[ S_i \setminus S_j \right] \tag{3}$$

i.e. a point of P(K) lies in S only if it has multiple degeneracies. Note that if P(K) is one complex-dimensional (which Theorem 17 indicates whenever M has a single cusp) then dimensional considerations suggest S will be empty.

The following lemma shows how the existence and rigidity of hextets (Corollary 8) allows us to construct holonomy representations from coherent ortholongth parameters.

**Lemma 14** To each coherent realisation of  $p \ge P(K) nT$  by hextets there exists a corresponding representation :  $_1(M;)$  !  $PSL_2\mathbb{C}$  so that  $Orth_K()$  = p. Furthermore, up to conjugacy there are at most a nite number of represenfor which  $Orth_K() = p$  and there is only one if  $p \not a S$ .

Hence this lemma implies that, in P(K) nT, the image of  $Orth_K: X(M) \longrightarrow$ P(K) is exactly the set of coherent orthologish parameters.

Before proving Lemma 14 we pause briefly to describe part of the relationship between Thurston and SnapPea's parameterisation of X(M) via ideal hyperbolic tetrahedra (see [25], [28], [22]) and the parameterisation of X(M)described in Lemma 14 via orthologiths  $p \ge P(K)$ . To each hextet there is an associated ideal hyperbolic tetrahedron whose vertices are the second endpoints<sup>11</sup> of the four oriented lines comprising the hextet. So given a coherent realisation of  $p \ 2 \ P(K)$ , we can associate a hyperbolic ideal tetrahedron to each (topological) ideal tetrahedron of K. Then SnapPea's edge-consistency conditions are automatically satis ed for these geometric tetrahedra. To see this, consider all the tetrahedra of K surrounding an edge  $e_i$  of K. In a hextet which realises one of these tetrahedra, two of the four lines comprising the hextet correspond to edge  $e_i$  (and hence cosh of the complex distance between

The second end-point of an oriented line (p;q)  $2 \mathbb{S}_1^2$  $\mathbb{S}^2$  n is q.

these two lines is  $p_i$ ). By acting by (orientation-preserving) isometries if need be we can assume that these two lines are the same for each hextet. But then the pair of right-angled hexagons corresponding to a face F of K containing edge  $e_i$  must also coincide (since they are isometric by the assumption of coherence and they share two distinct lines). Associating hyperbolic ideal tetrahedra (as above) to each of these hextets therefore gives geometrical tetrahedra whose faces coincide and which t together smoothly about their shared edge.

The shape of a hyperbolic ideal tetrahedron is determined by a complex shape parameter (see [25]). The shape parameter  $z \ 2 \ \mathbb{C}$  of the hyperbolic tetrahedron associated (by the above procedure) to a given hextet satis es an equation in cosh of the complex distances between the lines of the hextet. This equation is quite large but it is clearly quadratic in z, reflecting the fact that a set of ortholengths only determine a corresponding hextet up to orientation.

**Proof of Lemma 14** Let  $p \ 2 \ P(K) \ n \ T$  be coherent and let  $H_1; \dots; H_n$  be a coherent realisation of p by hextets, where  $H_j$  corresponds to the  $j^{th}$  tetrahedron  $\mathcal{A}_j$  of K. We can pull the ideal triangulation K back to an ideal triangulation K of the universal cover  $\widehat{M}$  of M via the covering map  $\widehat{M} \ ! \ M$ . Then every tetrahedron, face and edge of K covers one of the tetrahedra, faces or edges (respectively) of K. Let  $K^{(3)}$  denote the set of tetrahedra of K. We will consider a function  $H: K^{(3)} \ ! \ (SL)^4$  which associates a hextet to each tetrahedron of K. This is as an association of an oriented line to each of the four corners of each tetrahedron of K. We require that H satis es two conditions: (1) if  $\mathcal{A} \ 2 \ K^{(3)}$  covers the  $f^{th}$  tetrahedron  $\mathcal{A}_f$  of K then the hextet  $H(\mathcal{A})$  is isometric to  $H_f$  and (2) if two tetrahedra  $\mathcal{A}_f \ \mathcal{A}^f \ 2 \ K^{(3)}$  share a face T of K then the right-angled hexagons corresponding to T in  $H(\mathcal{A})$  and  $H(\mathcal{A}^f)$  are identical.

We will show that to each coherent realisation of p by hextets there is a corresponding function  $H: \mathcal{R}^{(3)}$  !  $(SL)^4$  which satis es the above two conditions, and that this function is unique up to (orientation-preserving) isometry. Before proving this we rst show how the existence and rigidity of such a 'skeletal developing map' H proves the lemma.

Given such an H, by its uniqueness up to isometry we know that for each deck-transformation of the covering M! M there is a unique isometry ( )  $2 \operatorname{PSL}_2 \mathbb{C}$  which makes the following diagram

commute. Choosing a base-point  $\sim 2\,\bar{M}$  covering  $2\,M$  allows us to identify the deck transformations of the covering  $\bar{M}$ ! M with  $_1(M)$ , and hence becomes a function  $_1(M)$ !  $PSL_2\mathbb{C}$ . It follows easily from the denition that  $_1(M)$ !  $PSL_2\mathbb{C}$  is actually a homomorphism, and it is well-dened up to conjugacy since using a dierent H or a dierent base-point  $\sim$  simply has the elect of conjugating by an isometry.

By construction, translates under  $(_1(M; ))$  of the line which is xed by  $(_1(N; ))$  are simply the lines occurring in the image of H, so  $Orth_K() = p$ . Up to isometry there are at most  $2^n$  di erent realisations of p and so there are at most this many representations—with  $Orth_K() = p$  (up to conjugacy). Also, if  $p \ge S$  then up to isometry there are at most two coherent realisations of p, and these are the same except that they have opposite orientations. (This is because the orientation of one hextet determines the orientations of all other hextets in a coherent realisation of p whenever all or all but one of the hexagonal faces are non-degenerate, see point (3) of Lemma 10.) These two realisations therefore give rise to functions  $H: K^{(3)} ! (SL)^4$  which are identical (up to isometry) except that all of their lines are of opposite orientation. Clearly the holonomy representations corresponding to such H are identical.

The rest of the proof is devoted to showing that, corresponding to a coherent realisation  $H_1; \ldots; H_n$  of p, there is a function  $H: \mathcal{R}^{(3)}$ ! (SL)<sup>4</sup> which satis es the two conditions listed in the rst paragraph of this proof and furthermore that such an H is unique up to (orientation-preserving) isometry.

Dual to  $\mathcal{K}$  in  $\mathcal{M}$  there is a 2-dimensional CW-complex  $\mathcal{C}$  whose underlying space  $j\mathcal{C}j$  is a deformation retract of  $\mathcal{M}$  and so in particular  $j\mathcal{C}j$  is simply connected. Let denote a nite sequence  $_1; \ldots; _m$  of oriented 1-cells in  $\mathcal{C}$  so that  $_i(1) = _{i+1}(0)$  for each  $i = 1; \ldots; m-1$ , where  $_i(0)$  denotes the start of the 1-cell  $_i$  and  $_i(1)$  denotes the end of it. Let  $x_0 = _1(0)$  and let  $x_i = _i(1)$  for each  $i = 1; \ldots; m$ . We think of as a path in the 1-skeleton of  $\mathcal{C}$  from  $x_0$  to  $x_m$ .

For each  $i=1;\ldots;m$ , the 0-cell  $x_i$  is dual to a tetrahedron  $\mathcal{A}_i$  (say) of  $\mathcal{K}$ , and each tetrahedron  $\mathcal{A}_i$  covers a tetrahedron  $\mathcal{A}_{j(i)}$  of  $\mathcal{K}$  (for some j(i) 2  $f1;\ldots;ng$ ). Given a choice of hextet  $H_0^{\emptyset}$  isometric to  $H_{j(0)}$ , we de ne a sequence  $H_0^{\emptyset};\ldots;H_m^{\emptyset}$  of hextets with each  $H_i^{\emptyset}$  isometric to  $H_{j(i)}$  as follows. Assume that  $H_{i-1}^{\emptyset}$  is de ned. Then the 1-cell i is dual to some 2-simplex  $\mathfrak{F}$  of  $\mathfrak{K}$  which is contained in both  $\mathfrak{A}_{i-1}$  and  $\mathfrak{A}_i$ . Let T be the 2-simplex of K covered by  $\mathfrak{F}$ . By the coherence of p we know that the right-angled hexagons in  $H_{j(i-1)}$  and  $H_{j(i)}$  corresponding to T are isometric. Since  $H_{i-1}^{\emptyset}$  is isometric to  $H_{j(i-1)}$  we can de ne  $H_i^{\emptyset}$  as the hextet which is isometric to  $H_{j(i)}$  and for which the

right-angled hexagons in  $H_{i-1}^{\emptyset}$  and  $H_i^{\emptyset}$  corresponding to  $\mathcal{F}$  are identical. This uniquely determines  $H_i^{\emptyset}$  because there is no non-trivial (orientation-preserving) isometry—xing the right-angled hexagon corresponding to  $\mathcal{F}$ , since no  $p_i=1$  and so the hexagon has at least three end-points on  $\mathbb{S}^2_{\mathcal{T}}$ . Hence to any such path—and any choice  $H_0^{\emptyset}$  we have a corresponding sequence  $H_0^{\emptyset}$ ::::; $H_m^{\emptyset}$  of hextets.

Now, choose some  $\mathcal{A} \supseteq \mathcal{K}^{(3)}$  (which covers the  $j^{th}$  tetrahedron  $\mathcal{A}_j$  of  $\mathcal{K}$ , say) and choose a hextet which is isometric to  $\mathcal{H}_j$  and denote it by  $\mathcal{H}(\mathcal{A})$ . Let be the 0-cell of  $\mathcal{C}$  dual to  $\mathcal{A}$ . Given any other  $\mathcal{A}^{\emptyset} \supseteq \mathcal{K}^{(3)}$ , dual to some 0-cell  $\mathcal{X}$  of  $\mathcal{C}$ , choose a path—as above with  $\mathcal{X}_0 = \text{and } \mathcal{X}_m = \mathcal{X}$ . Then form the corresponding sequence  $\mathcal{H}_0^{\emptyset} : \ldots : \mathcal{H}_m^{\emptyset}$  of hextets as defined above with  $\mathcal{H}_0^{\emptyset} = \mathcal{H}(\mathcal{A})$  and define  $\mathcal{H}(\mathcal{A}^{\emptyset})$  to be  $\mathcal{H}_m^{\emptyset}$ .

To see that this de nition is independent of the path from to x, note that any two such paths are homotopic in jCj. It therefore surces to show that the holonomy around the boundary of any of the 2-cells of C is trivial, i.e. that if is a path tracing once around a 2-cell of C then in the corresponding sequence  $H_0^\emptyset, \ldots, H_m^\emptyset$  of hextets de ned above,  $H_0^\emptyset = H_m^\emptyset$ . But for such a , all of the tetrahedra  $\mathcal{A}_0, \ldots, \mathcal{A}_m$  share an edge in  $\mathcal{K}$  and so by construction all of the hextets  $H_0^\emptyset, \ldots, H_m^\emptyset$  have two lines in common. So the hextets  $H_0^\emptyset$  and  $H_m^\emptyset$  share two lines and are isometric (since  $\mathcal{A}_0 = \mathcal{A}_m$ ). Then since there are no non-trivial orientation-preserving isometries xing two distinct lines in  $\mathbb{H}^3$ ,  $H_0^\emptyset = H_m^\emptyset$  as required.

It is clear that  $H: \mathcal{R}^{(3)}$  !  $(SL)^4$  as constructed satis es the two de ning conditions given in the rst paragraph of this proof, and conversely any such H can be constructed in this way. Hence the existence and rigidity of H is proved.

Non-coherent ortholongths correspond to representations into  $PSL_2\mathbb{C}$  of the fundamental groups of nite-sheeted covers or branched covers of  $\mathcal{M}$ , branched over the edges of  $\mathcal{K}$ . Hence non-coherent ortholongths seem to be more related to the ideal triangulation  $\mathcal{K}$  than to intrinsic properties of the 3-manifold  $\mathcal{M}$ .

We next show that the property of coherence is locally constant on the complement of a certain subvariety of P(K). This proof is a deformation argument in which we make use of the fact that in some sense there exists a continuous local parameterisation of hextets by their ortholengths. We pause now briefly to give a precise description of this local parameterisation.

Now, by Corollary 8 and Lemma 10,  $D_4$  is onto and it is two-to-one everywhere except on the set of degenerate hextets where  $D_4$  is instead one-to-one. **Lemma 15** The property of coherence is locally constant on P(K) n(S [T):

**Proof** Let a be a point of P(K) n(S[T)) and for each  $i=1,\ldots,n$ , choose a numbering from 1 to 4 for the vertices of the  $i^{th}$  tetrahedron  $\mathcal{A}_i$  of K. Now, let F be any face of K and suppose that F is contained in tetrahedra  $\mathcal{A}_i$  and  $\mathcal{A}_j$  of K. If we choose a numbering from 1 to 3 for the vertices of F then we can de ne several projection maps. Firstly a projection F: P(K)! P(F) essentially given by forgetting all ortholength parameters except those associated to the edges of F. Also, a map  $_i: RH_4$ !  $RH_3$  which rst forgets the line of  $H_i^q$  2  $RH_4$  corresponding to the vertex of  $\mathcal{A}_i$  not contained in F and which then acts by an (orientation-preserving) isometry to bring the resulting right-angled hexagon into standard position. Similarly we have a map  $_i: RH_4$ !  $RH_3$ .

Now, if the right-angled hexagons corresponding to F in  $H_i^q$  and  $H_j^q$  are degenerate then they are isometric by Lemma 10. Hence we can restrict our attention

to the set  $U^{\emptyset}$  consisting of  $q \ 2 \ U$  so that  $H_i^q$  and  $H_j^q$  are non-degenerate. Then  $i \sim_i : U^{\emptyset} \ !$   $RH_3$  and  $j \sim_j : U^{\emptyset} \ !$   $RH_3$  are both lifts of the restriction  $F_jU^{\emptyset}$  of  $F_j$  to  $U^{\emptyset}$  and they agree at  $P_j$ . Hence by the uniqueness of lifts to covering spaces (see [4]),  $i \sim_i = j \sim_j$  and so the right-angled hexagons corresponding to  $F_j$  in  $H_j^q$  and  $H_j^q$  are again isometric.

**Lemma 16** The limit of a sequence of coherent points in P(K) is coherent.

**Proof** This lemma follows from the fact that the inverse images of compact sets in P(4) under  $D_4: RH_4! P(4)$  are compact.

A rational map between two irreducible complex varieties which is generically <sup>13</sup> de ned, injective and onto has a rational inverse and is called a birational equivalence (see [14, p.77]). Hence Lemmas 14, 15 and 16 combine to give the following theorem.

**Theorem 17** Let C be an irreducible component of X(M) on which  $Orth_K$  is generically defined and suppose that the set-theoretic image of C under the rational map  $Orth_K: X(M) \dashrightarrow P(K)$  contains some point  $p = (p_1; \dots; p_n) \ 2$  P(K) for which  $p \ 2$  S (see equation (3)) and no  $p_i = 1$ . Then  $Orth_K$  restricts to a birational equivalence between C and an irreducible component of P(K).

Let Hol: H(M)! X(M) be the map which takes a hyperbolic structure and returns its holonomy representation modulo conjugacy. Then as in Section 3, the ortholength invariant of an incomplete hyperbolic structure  $M_0$  2 H(M) is  $Orth_K$   $Hol(M_0)$ . Recall also that we say that an incomplete hyperbolic structure on M corresponds to a (topological) Dehn Iling if the metric completion of M is a closed manifold (homeomorphic to a topological Dehn Iling of M) with a smooth hyperbolic structure.

**Theorem 18** Let  $M_0$  2 H(M) be an incomplete hyperbolic structure whose ortholength invariant  $p = (p_1; ...; p_n)$  2 P(K) is not contained in S (see equation (3)) and which has no  $p_i = 1$ . Then:

If  $M_0$  corresponds to a (topological) Dehn lling of M then  $M_0$  is uniquely determined by  $\rho$ .

The ortholongth invariant  $Orth_K : X(M) \longrightarrow P(K)$  restricts to a di eomorphism from a neighbourhood of  $Hol(M_0)$  in X(M) to a neighbourhood of p in P(K).

The holonomy map Hol is a local homeomorphism (e.g. see [25, x5.2] or [11]) so we can endow H(M) with a smooth structure coming from X(M). Then the second point of this theorem says that (generically) the ortholongth invariant smoothly locally parameterises incomplete hyperbolic structures on M.

**Proof of Theorem 18** A hyperbolic structure which corresponds to a topological Dehn lling of M is determined by its holonomy representation. This is a 'folk-lore' result which is true essentially because, in this case, the image of the holonomy representation is a discrete Kleinian group, and its action on  $\mathbb{H}^3$  has a quotient isometric to the metric completion of M. But by Lemma 14, the orthologish invariant p determines the holonomy representation whenever  $p \not a S$  and no  $p_i = 1$ . This proves the rst point of the corollary.

Now,  $Orth_K$  is de ned on every representation which arises as the holonomy of one of the hyperbolic structures of H(M) (see Section 3). Then since the conditions (2) are open,  $Orth_K$  is de ned in a neighbourhood of  $Hol(M_0)$ . From the formula of Proposition 12 it is clear that  $Orth_K$  is smooth in this neighbourhood.

On the other hand, p is coherent by the construction used to de ne the ortholength invariant in Section 3. By Lemma 15 this implies that all ortholength parameters in a neighbourhood of p are also coherent. Hence by Lemma 14 there is a local inverse to  $Orth_K$  de ned in a neighbourhood of p. This inverse is smooth by the construction given in Lemma 14, since the representation given there is determined by a nite portion of the skeletal developing map H and the hextets used to build this map all vary smoothly with p. This last result follows from the discussion preceding Lemma 15 and the fact that if  $p \ allowseleft S$  then the hextets in a realisation of p are all non-degenerate.

Theorems 17 and 18 are vacuous unless there exists some incomplete hyperbolic structure with ortholength invariant p such that  $p \not \ge S$  and no  $p_i = 1$ . This will probably be the case whenever the edges of K are homotopically non-trivial, however until such a general result can be established we have the following lemma.

**Lemma 19** If the ideal triangulation K is Epstein-Penner's [9] ideal cell-decomposition of M then there exists an incomplete hyperbolic structure with orthologish invariant p such that  $p \ge S$  and no  $p_i = 1$ .

The full proof of this lemma relies on the notion of a 'tube domain' (see Section 6 and [8, Lemma 4.7]) so we content ourselves here with a sketch.

**Sketch of a proof of Lemma 19** Corresponding to the complete hyperbolic structure on M there is a 2-complex in M which is the image of the boundary of the Ford domain of *M* under the face-pairing identications. This Ford 2-complex is dual to K (see [9]). Let  $\overline{M}$  be a (topological) Dehn lling of M with very large Dehn surgery co-ordinates and let be the added 'core' geodesic of  $\overline{M}$ , hence  $\overline{M}$  is hyperbolic and  $M = \overline{M} n$ . The cut-locus of  $\overline{M}$  is a 2-complex which (for very large Dehn llings) is a small perturbation of the Ford 2-complex, and so in particular this cut-locus is also topologically dual to K (see [8]). Now, the pre-image of under a (xed) covering isometry  $\mathbb{H}^3$  !  $\overline{M}$  is a collection of disjoint lines in  $\mathbb{H}^3$ . If  $F_j$  is a 2-simplex of K and  $\hat{\mathcal{F}}_j$  is a lift to  $\mathbb{H}^3$  then each corner of  $\hat{\mathcal{F}}_j$  determines one of these lines. The complex distances between these three distinguished lines are given by the three ortholength parameters  $p_i$  attached to the corresponding edges of  $F_i$ , where  $p = (p_1, \dots, p_n)$  is the orthologish invariant of the hyperbolic structure on M induced from M !  $\overline{M}$ . Then the set of points of  $\mathbb{H}^3$  which are equidistant from all three lines simultaneously is non-empty, since this set contains a lift of a certain part of the cut-locus of , namely the 1-cell dual to  $F_i$ .

But if p lies in  $S_j$  then this is a contradiction. In this case, the three lines corresponding to the corners of  $\mathcal{F}_j$  have a common perpendicular line n (by Lemma 10). Since  $\overline{M}$  is a large Dehn lling, all of its ortholengths will be very large and so the distances between these three lines are also large (and no  $p_i = 1$ ). This implies that the locus of points equidistant from any pair of lines is close to the plane which is perpendicular to n and lies mid-way between the two lines. Hence there can be no point of  $\mathbb{H}^3$  which is equidistant from all three lines simultaneously.

### 5 Examples

In this section we describe the ortholongth invariant  $Orth_K : X(M) \dashrightarrow P(K)$  for the gure-8 knot complement M.




Figure 3: The gure-8 knot

Let  $\mathcal{M}$  be the complement in  $\mathbb{S}^3$  of the gure-8 knot (see Figure 3). A result of Epstein and Penner (see [9]) says that every 1-cusped hyperbolic 3-manifold has a canonical ideal cell-decomposition. For the gure-8 knot complement  $\mathcal{M}$ , this




Figure 4: The canonical ideal triangulation K for the gure-8 knot complement

cell-decomposition is the ideal triangulation K shown<sup>15</sup> in Figure 4 (see [27]). This ideal triangulation for the gure-8 knot complement was rst described by Thurston [25].

The ideal triangulation K has two edge classes,  $e_0$  and  $e_1$ . Let  $p_0$  be the ortholength parameter corresponding to edge class  $e_0$  and let  $p_1$  correspond to  $e_1$ . Then the hextet equation (see De nition 11) of tetrahedron 0 is

The hextet equation of tetrahedron 1 is identical, so P(K)  $\mathbb{C}^2$  is the plane algebraic curve given by equation (5). From (5) we see that P(K) is the union of a conic (whose projective completion is topologically a smooth sphere) and two lines.




Figure 5: The loops corresponding to the generators of the presentation for  $_1(M;\;)$  based on K

Following the notation of Section 3 we take N-M to be a closed tubular neighbourhood of the gure-8 knot minus the knot itself. Then the generators of the presentation of  $_1(M; )$  based on K (see the discussion preceding Proposition 12) are as shown in Figure 5.

Now, let  $t_1 = t_1^{-1} m$  and  $t_2 = m$ . These are the generators of a presentation

which is derived from a Wirtinger presentation for  $_1(M_7)$ . We do not wo complex algebraic functions X and Y on the space of representations of  $_1(M_7)$  into  $SL_2\mathbb{C}$  by

$$X(\sim) = \text{tr}(\sim(t_1)) = \text{tr}(\sim(t_2))$$
 and  $Y(\sim) = \text{tr}(\sim(t_1t_2))$ 

for any representation  $\sim$ :  $_1(M)$ ) !  $SL_2\mathbb{C}$ . These functions are clearly conjugacy invariant, so they descend to functions (also denoted X and Y) on the  $SL_2\mathbb{C}$ -character variety  $^{16}$ . In fact, X and Y are the co-ordinate functions of an embedding of the  $SL_2\mathbb{C}$ -character variety in  $\mathbb{C}^2$  as the complex curve given by

$$0 = (X^{2} - Y - 2)(X^{2}Y - 2X^{2} - Y^{2} + Y + 1)$$
 (7)

(see Gonzalez-Acuna and Montesinos-Amilibia's paper [12]).

Now, from the presentation (6) above it is clear that each representation :  $_1(M; )$  !  $PSL_2\mathbb{C}$  lifts to exactly two representation  $\sim$ :  $_1(M; )$  !  $SL_2\mathbb{C}$ . Hence there are well-de ned algebraic functions U and V de ned on the  $PSL_2\mathbb{C}$ -character variety X(M) by

$$U() = X^{2}(\sim) \text{ and } V() = X^{2}(\sim) - Y(\sim)$$

i.e. U and V are elements of the co-ordinate ring of X(M). By (7), these functions de ne an embedding of X(M) into  $\mathbb{C}^2$  as the complex curve given by the equation

$$0 = (V - 2)(V^2 - UV + V + U - 1):$$
(8)

Hence X(M) is composed of two irreducible components, one being the line V=2 and the other being the rational curve

$$U = \frac{V^2 + V - 1}{V - 1}. (9)$$

The line V = 2 corresponds to reducible representations (i.e. those which x a point on  $\mathbb{S}_7^2$ ) and the rational curve (9) corresponds to conjugacy classes of irreducible representations (see [12]).

We can now calculate  $Orth_{\mathcal{K}}: \mathcal{X}(M) \dashrightarrow \mathcal{P}(\mathcal{K})$  using the formula given in Proposition 12. The conditions (2) are satis ed at all points of  $\mathcal{X}(M)$  except the points with (U;V) equal to (4;2) or (4;1-), where  $2\mathbb{C}$  is a nontrivial cube root of unity. (These points correspond to the trivial representation and to the two orientation-preserving conjugacy classes of discrete and faithful representations.) Since the line V=2 corresponds to reducible representations (see [12])  $Orth_{\mathcal{K}}$  takes the whole line to the point (1;1). On the curve (9), Proposition 12 implies that

$$Orth_{K}(U;V) = \frac{1}{V^{2} - 3V + 3}(-V^{2} + 3V - 1;V^{2} - V - 1):$$
 (10)

From this expression it is easy to check that the image of  $Orth_K$  lies inside the conic component of P(K). From (10) and Figure 4, the ortholongth invariant  $Orth_K(U;V)$  lies in S whenever

$$0 = (V-2)^2(V^2 + V - 1)$$
 and  $0 = (V-2)^2(V-1)^2(V^2 + V - 1)$ ;

where (U;V) 2 X(M) belongs to the curve (9), i.e.  $Orth_K(U;V)$  2 S when V equals 2 or (-1)  $\overline{5}$  =2. Also, a simple calculation shows that  $Orth_K(U;V)$  2 P(K)  $\mathbb{C}^2$  has one or both co-ordinates equal to 1 if and only if V is 1 or 2. Hence by Theorem 17, the image of  $Orth_K$  is dense in the conic component of

P(K) and  $Orth_K$  restricts to a birational equivalence between this component and the curve (9). A simple calculation shows that the inverse of  $Orth_K$  on this curve is given by  $(p_0; p_1) \not V$  (U; V), where

$$V = \frac{2p_0 + p_1 + 1}{p_0 + 1}$$

and U is given by the equation (9).

### 6 Future applications

The work presented in this paper arose out of an attempt to construct families of incomplete hyperbolic structures on a cusped 3-manifold M and to estimate the boundary of the deformation space H(M) in Dehn surgery co-ordinates.

The connection between the ortholength invariant and these two problems is the concept of a *tube domain* (see [8]) which comes from collaborative work with Craig D. Hodgson. A tube domain can be de ned for any (incomplete) hyperbolic structure in H(M), but the description is simplest for those hyperbolic structures which correspond to topological Dehn llings of M. If  $\overline{M}$  is a hyperbolic Dehn lling of M then there is a covering isometry  $: \mathbb{H}^3 : \overline{M}$  and a distinguished simple closed geodesic in  $\overline{M}$  so that  $\overline{M}n$  is di eomorphic to M. We de ne the *tube domain* D of the Dehn lling to be (the closure of) the set  $\overline{D}$  of points of  $\overline{M}^3$  which are closer to a line  $\overline{C}$  of points of  $\overline{C}$  of points of  $\overline{C}$  which are closer to a line  $\overline{C}$  of the Dehn ling to be (There is a surjective map  $\overline{D}$ ?  $\overline{M}$  which makes the diagram

commute. The tube domain D is different emporation of a solid torus and its boundary is broken into (non-planar) faces which the map D!  $\overline{M}$  isometrically identifies in pairs.

On the other hand, the orthologish invariant of the hyperbolic structure  $\overline{M}n$  on M determines the set of lines  $^{-1}($  ) up to isometry (as detailed in the proof of Lemma 14). These in turn determine the corresponding tube domain D and its face-pairing isometries, and so give us back the original hyperbolic structure  $\overline{M}n$  on M. This gives us a method of constructing hyperbolic structures via tube domains which can be generalised to calculate hyperbolic structures with more general Dehn surgery-type singularities, including hyperbolic conemanifolds whose singular sets are simple closed geodesics. This approach has

been automated by Goodman-Hodgson in a computer program [13] called *Tube. Tube* naturally lends itself to calculating the tube radius and it has been used to calculate hyperbolic structures which SnapPea [28] fails to compute. For instance, *Tube* has calculated a hyperbolic structure for m004(4,0) (the hyperbolic cone-manifold with cone-angles =2 along the gure-8 knot) and for m007(3,1) (the manifold of third lowest volume on SnapPea's closed census) while SnapPea fails to compute a hyperbolic structure for m004(4,0) and there is no known positively oriented tetrahedral decomposition of m007(3,1). Also, the cone-manifolds over the gure-8 knot complement with cone angle strictly less than 2 =3 all have hyperbolic structures (see [15] and also [16,  $\chi$ 29]) but for cone angles bigger than 2 =4.767::: SnapPea's tetrahedral construction fails. In fact, Choi [5] has shown that there cannot exist a positively-oriented hyperbolic ideal triangulation for the cone-manifold over the gure-8 knot complement when cone-angles are 2 =4.767::: (i.e. when one of the tetrahedra of the canonical ideal triangulation flattens out).

The second problem which motivates the study of the ortholength invariant is the estimation of the boundary of H(M). The ortholength invariant seems especially suited to this task because of its close relationship with the tube radius and because of some suggestive connections between the tube radius and the degeneration of hyperbolic structures on M (e.g. see Kojima [19] and Hodgson-Kerckho [18], [17]). For a given (incomplete) hyperbolic structure  $M_0 \ 2 \ H(M)$ , there is a (topological) ideal triangulation  $K_0$  so that the tube radius of  $M_0$  is given in terms of  $Orth_{K_0}(M_0)$ . In particular, the tube radius of  $M_0$  will be non-zero whenever all co-ordinates of  $Orth_{K_0}(M_0)$  lie in  $\mathbb{C} \ n[-1;1]$ .

Each edge of this special ideal triangulation  $K_0$  corresponds to a pair of faces of the tube domain of  $M_0$ . The combinatorics of the tube domains and hence of the corresponding ideal triangulations  $K_0$  are locally constant in H(M) and also at the complete structure (see [8, x4.5]). Since H(M) is non-compact near its boundary, it is conceivable that in nitely many inequivalent triangulations  $K_0$  may arise as  $M_0$  varies over H(M). However, we conjecture that this in not the case, i.e. for any given M only a nite number  $K_1; \ldots; K_m$  of (topological) ideal triangulations are needed to compute the tube radii of the incomplete hyperbolic structures in H(M). For our irreducible manifold M, the conjecture of [18] reduces to the assertion that a family of hyperbolic structures degenerates if and only if their tube radii approach zero. This motivates the following conjecture.

**Conjecture 20** Let M be the underlying smooth manifold of an orientable, 1-cusped hyperbolic 3-manifold of nite volume. Then there are a nite number

of (topological) ideal triangulations  $K_1, \ldots, K_m$  of M so that a sequence of (incomplete) hyperbolic structures in H(M) has a limit in H(M) if and only if the corresponding m sequences of orthologish invariants with respect to the ideal triangulations  $K_1, \ldots, K_m$  all have limits with co-ordinates  $\cosh d_i$  in  $\mathbb{C}[n-1,1]$ .

For instance, when M is the gure-8 knot complement, computational evidence suggests that this conjecture is true with m=1 and  $\mathcal{K}_1$  the ideal triangulation of Section 5. More specifically, in Dehn surgery co-ordinates the zero-volume set (which in this case is conjectured to be the boundary of H(M), see [25], [16]) appears to coincide with the frontier of the set of hyperbolic structures with  $p_0$ ,  $p_1 \not B[-1;1]$   $\mathbb{C}$ , where  $(p_0;p_1)$  is the orthologish invariant of Section 5.

Practical conditions to determine when the tube domain construction fails may provide rigorous estimates about the boundary of  $\mathcal{H}(\mathcal{M})$ , especially in special cases such as the gure-8 knot complement. Analogies between the construction (in practice) of Dirichlet domains and the construction of tube domains suggest possible necessary conditions for the failure of the tube domain construction though no useful estimates have emerged from this approach so far.

We can also attempt to use *ortho-angles* (which are dual to the ortholengths) to parameterise H(M). The ortho-angles are more directly related to the Dehn surgery co-ordinates of H(M) than the ortholengths and they are very well-behaved near the complete structure. This makes the ortho-angle parameterisation of H(M) quite a promising line of research.

Finally we note that even though we have restricted our attention in this paper to single-cusped 3-manifolds, the main de nitions and proofs<sup>17</sup> trivially extend to 3-manifolds with multiple cusps.
