# The sigma orientation for analytic circle-equivariant elliptic cohomology

#### **Abstract**

We construct a *canonical* Thom isomorphism in Grojnowski's equivariant elliptic cohomology, for virtual  $\mathbb{T}$ -oriented  $\mathbb{T}$ -equivariant spin bundles with vanishing Borel-equivariant second Chern class, which is natural under pull-back of vector bundles and exponential under Whitney sum. It extends in the complexanalytic case the non-equivariant sigma orientation of Hopkins, Strickland, and the author. The construction relates the sigma orientation to the representation theory of loop groups and Looijenga's weighted projective space, and sheds light even on the non-equivariant case. Rigidity theorems of Witten-Bott-Taubes including generalizations by Kefeng Liu follow.

### 1 Introduction

Let E be an even periodic, homotopy commutative ring spectrum, let C be an elliptic curve over  $S_E = \operatorname{spec}_{0} E$ , and let t be an isomorphism of formal groups

$$t: \mathcal{O} = \operatorname{spf} E^0(\mathbb{C}P^1);$$

so that (E;C;t) is an elliptic spectrum in the sense of [13, 2]. In [2], Hopkins, Strickland, and the author construct a canonical map of homotopy commutative ring spectra

$$(E;C;t):MUh6i \vdash E$$

called the *sigma orientation*; it is conjectured in [13] that this map is the restriction to MUh6i of a similar map MOh8i! E:

Let  $\mathbb{T}$  be the circle group. We expect that there is an equivariant elliptic spectrum  $(E_{\mathbb{T}};C;t)$  extending the nonequivariant elliptic spectrum (E;C;t), and that the sigma orientation extends to a multiplicative map of  $\mathbb{T}$ -equivariant spectra

$$_{\mathbb{T}}(E_{\mathbb{T}};C;t):(\mathbb{T}\text{-equivariant }MOh8i) \vdash E_{\mathbb{T}}: \tag{1.1}$$

Note however that the construction of  $_{\mathbb{T}}$  requires us among other things to say what  $\mathbb{T}$ -spectra we have in mind for the domain and codomain.

If V is a virtual vector bundle over a space X, let  $X^V$  denote its Thom spectrum. In principle, giving a map  $_{\mathbb{T}}$  as in (1.1) should be equivalent to specifying, for each virtual  $\mathbb{T}$ -BOh8i vector bundle (whatever that means) a trivialization (V) of  $E_{\mathbb{T}}(X^V)$  as an  $E_{\mathbb{T}}(X)$ -module; the trivialization should be stable, exponential, and natural as V=X ranges over the virtual  $\mathbb{T}$ -BOh8i vector bundles.

The trivializations (V) should be compatible with the nonequivariant sigma orientation in the following way. If X is a  $\mathbb{T}$ -space, then  $X_{\mathbb{T}}$  will denote the Borel construction  $E\mathbb{T}_{\mathbb{T}}X$ ; if V is a (virtual)  $\mathbb{T}$ -vector bundle over X, then  $V_{\mathbb{T}}$  will denote the corresponding (virtual) bundle over  $X_{\mathbb{T}}$ . A  $\mathbb{T}$ -BOh8i structure on a  $\mathbb{T}$ -bundle should at least give a BOh8i structure to  $V_{\mathbb{T}}$ . One expects that the equivariant extension  $E_{\mathbb{T}}$  of an elliptic cohomology theory E comes with a completion isomorphism

$$E_{\mathbb{T}}(X)^{\hat{}} = E(X_{\mathbb{T}}); \tag{1.2}$$

and in particular

$$E_{\mathbb{T}}(X^{V})^{\hat{}} = E((X_{\mathbb{T}})^{V_{\mathbb{T}}}) : \tag{1.3}$$

The desired compatibility is that this isomorphism carries (V) to the sigma orientation of  $V_{\mathbb{T}}$ .

In this paper we take  $E_{\mathbb{T}}$  to be the complex-analytic equivariant elliptic cohomology of Grojnowski. Let  $\mathbb{C}$  be a lattice in the complex plane, and let C be the analytic variety  $C = \mathbb{C} = \mathbb{C}$ . Grojnowski constructs a functor  $E_{\mathbb{T}}$  from nite  $\mathbb{T}$ -CW complexes to sheaves of  $\mathbb{Z}$ -2-graded  $O_C$ -algebras, equipped with a natural isomorphism (1.2), where the left side denotes the completion of the stalk of  $E_{\mathbb{T}}(X)$  at the origin of C ([11]; for a published account see [19, 1]).

The bundles for which we construct trivializations (V) are the *virtual*  $\mathbb{T}$ oriented equivariant spin bundles V with  $c_2(V_{\mathbb{T}})=0$ . This requires some explanation.

Let V be a  $\mathbb{T}$ -vector bundle over X. A  $\mathbb{T}$ -orientation on V is a choice of orientation  $(V^A)$  on the xed sub-bundle  $V^A$  for each closed subgroup A of  $\mathbb{T}$ . We say that V is  $\mathbb{T}$ -orientable if it admits a  $\mathbb{T}$ -orientation; a  $\mathbb{T}$ -oriented vector bundle is a  $\mathbb{T}$ -vector bundle equipped with a  $\mathbb{T}$ -orientation. An isomorphism of  $\mathbb{T}$ -oriented vector bundles is an isomorphism of  $\mathbb{T}$ -vector bundles which preserves the orientations on each of the xed sub-bundles.

A  $\mathbb{T}$ -equivariant spin bundle is a spin vector bundle V, equipped with an action of  $\mathbb{T}$  on its principal spin bundle Q! X. If V is a  $\mathbb{T}$ -equivariant spin bundle with principal spin bundle Q, then the Borel construction  $Q_{\mathbb{T}}$  is a principal spin bundle over  $X_{\mathbb{T}}$ ; the associated spin vector bundle is  $V_{\mathbb{T}}$ .

Since we produce a section of the sheaf which corresponds in Grojnowski's  $E_{\mathbb{T}}$  to the cohomology of the Thom spectrum of a virtual bundle, it is important to identify this sheaf precisely, rather than merely its isomorphism class. Our approach is to construct the section for a pair  $V = V = X = (V_0 : V_1)$  of  $\mathbb{T}$ -oriented equivariant spin vector bundles over X, representing the virtual bundle  $V_0 - V_1$ , and then state explicitly how the construction depends on the pair. We choose not to write  $V = V_0 - V_1$ , to emphasize that we are working with genuine vector bundles and not mere isomorphism classes. In particular the virtual bundles over X do not form an abelian group. On the other hand, if V is such a pair, then  $X^V$  will denote the Thom spectrum of the virtual bundle  $V_0 - V_1$ .

If  $V = (V_0, V_1)$  is a pair of vector bundles over X, and f : Y ! X is a map, then we write f V for the pair  $(f V_0, f V_1)$  of vector bundles over Y. A map

$$g=f: W=Y ! V=X$$

of pairs of vector bundles will mean a map of spaces

and maps of vector bundles

$$\begin{array}{cccc}
W_i & \xrightarrow{g_i} & V_i \\
\vdots & & \vdots \\
Y & \xrightarrow{f} & X
\end{array}$$
(1.4)

covering f for i=0; 1. Such a map will be called a *pull-back* if the diagram (1.4) is a pull-back for each i. If V is a pair of  $\mathbb{T}$ -vector bundles, then we write  $V_{\mathbb{T}}$  for the pair  $((V_0)_{\mathbb{T}}; (V_1)_{\mathbb{T}})$ : If  $V^{\ell} = (V_0^{\ell}; V_1^{\ell})$  is another pair of vector bundles over X, then we write V  $V^{\ell}$  for the pair  $(V_0 \quad V_0^{\ell}; V_1 \quad V_1^{\ell})$  over X.

A spin vector bundle V has an integral characteristic class, twice which is the rst Pontrjagin class. It is called  $\frac{p_1}{2}$  in [7] and in [8]. The isomorphism

$$H^4(BSU; \mathbb{Z}) = H^4(BSpin; \mathbb{Z})$$

identi es it with the second Chern class, so we call it  $c_2$  as in [2]. If  $V = (V_0, V_1)$  is a pair of spin bundles, then we de ne  $c_2(V) = c_2(V_0) - c_2(V_1)$ .

If V is a  $\mathbb{T}$ -equivariant vector bundle over X, then we write  $E_{\mathbb{T}}(V)$  for the reduced equivariant elliptic cohomology of its Thom space. It is an  $E_{\mathbb{T}}(X)$ -module, and if V is  $\mathbb{T}$ -orientable, then it is an invertible  $E_{\mathbb{T}}(X)$ -module (see section 7 and [19, 1]). If V and  $V^{\emptyset}$  are two such bundles then there is a canonical isomorphism of  $E_{\mathbb{T}}(X)$ -modules

$$E_{\mathbb{T}}(V \quad V^{\emptyset}) = E_{\mathbb{T}}(V) \underset{E_{\mathbb{T}}(X)}{=} E_{\mathbb{T}}(V^{\emptyset}): \tag{1.5}$$

If V is a  $\mathbb{T}$ -oriented vector bundle, and f:Y! X is an equivariant map, then there is a canonical isomorphism

$$E_{\mathbb{T}}(f \ V) = f \ E_{\mathbb{T}}(V) \tag{1.6}$$

of sheaves of  $E_{\mathbb{T}}(Y)$ -modules.

If  $V = (V_0; V_1)$  is a pair of  $\mathbb{T}$ -oriented vector bundles over X, then we de ne

$$E_{\mathbb{T}}(V) \stackrel{\mathrm{def}}{=} E_{\mathbb{T}}(V_0) \underset{E_{\mathbb{T}}(X)}{=} E_{\mathbb{T}}(V_1)^{-1} :$$

Equations (1.5) and (1.6) imply that the assignment  $V \not \! P \ E_{\mathbb{T}}(V)$  is

(1) *stable* in the sense that if W is a  $\mathbb{T}$ -oriented vector bundle over X, and if  $V^{\ell} = (V_0 \quad W; V_1 \quad W)$ , then there is a canonical isomorphism

$$E_{\mathbb{T}}(V^{\emptyset}) = E_{\mathbb{T}}(V); \tag{1.7}$$

(2) natural in the sense that if

$$q=f: W=Y ! V=X$$

is a pull-back of pairs of  $\ensuremath{\mathbb{T}}\xspace$  -oriented vector bundles, then there is a canonical isomorphism

$$E_{\mathbb{T}}(g=f): E_{\mathbb{T}}(f) \ E_{\mathbb{T}}(V) = E_{\mathbb{T}}(W) \tag{1.8}$$

of  $E_{\mathbb{T}}(Y)$ -algebras.

(3) *exponential* in the sense that if  $V^{\ell} = (V_0^{\ell}, V_1^{\ell})$  is another  $\mathbb{T}$ -oriented vector bundle, then there is a canonical isomorphism

$$E_{\mathbb{T}}(V \quad V^{\emptyset}) = E_{\mathbb{T}}(V) \underset{E_{\mathbb{T}}(X)}{} E_{\mathbb{T}}(V^{\emptyset}) \tag{1.9}$$

extending (1.5).

Our main result is the following.

**Theorem 1.10** (9.1) Let  $V = (V_0; V_1)$  be a pair of  $\mathbb{T}$ -oriented equivariant spin vector bundles over a nite  $\mathbb{T}$ -CW complex X, with the property that  $c_2(V_{\mathbb{T}}) = 0$ : Then there is a canonical trivialization (V) of  $E_{\mathbb{T}}(V)$ , whose value in  $E_{\mathbb{T}}(V)^{\hat{}} = E(X_{\mathbb{T}}^{V_{\mathbb{T}}})$  is the Thom class provided by the (nonequivariant) sigma orientation.

The association  $V \not V$  (V) is stable in the sense that if W is a  $\mathbb{T}$ -oriented  $\mathbb{T}$ -equivariant spin bundle, and  $V^{\ell} = (V_0 \quad W; V_1 \quad W)$ , then

$$(V^{\theta}) = (V)$$

under the isomorphism (1.7). It is natural in the sense that if

$$q=f: W=Y ! V=X$$

is a pull-back of pairs of  $\mathbb{T}$ -oriented equivariant spin bundles with vanishing Borel second Chern class. then

$$E_{\mathbb{T}}(f)$$
  $(V) = (V^{\theta})$ 

under the isomorphism (1.8). It is exponential in the sense that if  $V^{\emptyset} = (V_0^{\emptyset}; V_1^{\emptyset})$  is another pair of  $\mathbb{T}$ -oriented  $\mathbb{T}$ -equivariant spin bundles with  $c_2(V_{\mathbb{T}}^{\emptyset}) = 0$ , then

$$(V V^{\theta}) = (V) (V^{\theta})$$

under the isomorphism (1.9).

**Remark 1.11** It is a result of Bott and Samelson ([6]; see [7] or Lemma 5.27) that a  $\mathbb{T}$ -equivariant spin bundle is  $\mathbb{T}$ -orientable.

**Remark 1.12** The class (V) depends on the  $\mathbb{T}$ -orientation and spin structure, but otherwise requires only that  $c_2(V_{\mathbb{T}})=0$ , i.e. that  $V_{\mathbb{T}}$  admits a BOh8i-structure. We suspect that the failure of our construction to depend on the choice of BOh8i structure on  $V_{\mathbb{T}}$  reflects the fact that our elliptic curve C comes as a quotient  $\mathbb{C}=$ . For example in Lemma 5.20, it is important to be able to name the point  $q^{\frac{1}{D}}$ . This is similar to the situation of the Ochanine genus, whose rigidity requires only that V is a spin bundle.

In [1], Maria Basterra and the author showed that, under the hypotheses of the Theorem, there is a global section (V) of  $E_{\mathbb{T}}(V)$ , whose value in the stalk at the origin of C is the sigma orientation of  $V_{\mathbb{T}}$ ; earlier Rosu [19] did the same for the orientation associated to the Euler formal group law. However, those papers do not address the trivialization, naturality, and exponential properties of the classes they construct.

The naturality is particularly hard to discern. Both of the papers [19, 1] closely follow [7] in their implementation of the \transfer" argument, and so all three papers depend on meticulous choices for integer representatives of the characters of the action of  $\mathbb{T}$  on  $Vj_{X^{\mathbb{T}}}$  and of  $\mathbb{T}[n]$  on  $Vj_{\mathbb{T}[n]}$  and for the orientations of  $V^{\mathbb{T}}$  and  $V^{\mathbb{T}[n]}$ , along with surprising and not particularly intuitive results concerning the compatibility of these choices. In this paper we show that *any* choice will do, with no e ect on the resulting Thom class, which is completely determined by the equivariant spin bundle V, together with the orientations of the bundles  $V^{\mathbb{T}[n]}$  and  $V^{\mathbb{T}}$ . The argument is indi erent to the parity of n.

From a practical point of view there are two important new ingredients. The rst is a careful account of the choice of representatives of characters (rotation numbers) for the action of A  $\mathbb{T}$  on the vector bundle  $Vj_{X^A}$ . This makes it easy to study the e ect on our constructions of varying the representatives and for that matter the subgroup A. The second is a systematic use of the geometry of the a ne Weyl group of Spin(2d), and its associated theory of theta functions [16].

More important than any single practical improvement was the conceptual progress in understanding the relationship between the sigma orientation and Looijenga's work on theta functions, root systems, and elliptic curves. In order to illustrate our thinking, we state a conjecture; it is really a proposal for structure which should be expected of equivariant elliptic cohomology, once a rich enough theory has been found.

Let E be the nonequivariant elliptic spectrum associated to C (see (2.10) for

a construction), and let

$$\operatorname{sp} E(X_{\mathbb{T}}) \stackrel{\text{def}}{=} \operatorname{spf} E^{0}(X_{\mathbb{T}})$$
:

Then  $X \not V$  sp  $E(X_{\mathbb{T}})$  is a covariant functor from  $\mathbb{T}$ -spaces to formal schemes over spf  $E^0(B\mathbb{T}) = \mathcal{O}$ . To state our conjecture, it is useful to suppose that  $\mathbb{T}$ -equivariant elliptic cohomology is a covariant functor

$$X \not \! I \operatorname{sp} E_{\mathbb{T}}(X)$$

from  $\mathbb{T}$ -spaces to some category of (super) ringed spaces over C, as was proposed by Grojnowski [11] and Ginzburg-Kapranov-Vasserot [9] (and perhaps others). For example, since Grojnowski's functor  $E_{\mathbb{T}}$  produces a  $\mathbb{Z}$ -2-graded commutative  $O_C$ -algebra, we may view  $(C; E_{\mathbb{T}}(X))$  as a ringed space sp  $E_{\mathbb{T}}(X)$  over C. In this notation the completion isomorphism (1.2) becomes

$$\operatorname{sp} E(X_{\mathbb{T}}) = (\operatorname{sp} E_{\mathbb{T}}(X))^{^{\wedge}}:$$

Let G = Spin(2d) with maximal torus T and Weyl group W, and let  $T = hom(\mathbb{T};T)$  be the lattice of cocharacters. The formal scheme T & carries a natural action of W, and the splitting principle gives an isomorphism (see section 4)

$$BG_E = (T \quad \&)=W$$
:

Suppose that V is a  $\mathbb{T}$ -vector bundle over X, and that  $V_{\mathbb{T}}$  has structure group G. The map

classifying V induces in E-cohomology a map

$$\operatorname{sp} E(X_{\mathbb{T}}) + (T \quad \mathcal{C}) = W. \tag{1.13}$$

Looijenga constructs a holomorphic line bundle A over (T C)=W ([16]; see also section 5.2). The sigma function de nes a global holomorphic section  $_d$  of A, whose zeroes de ne an ideal sheaf I on (T C)=W, such that  $_d$  is a *trivialization* of A I. Our conjecture is the following; it is stated with a little more detail as Conjecture 10.1.

**Conjecture 1.14** The  $\mathbb{T}$ -equivariant elliptic cohomology  $E_{\mathbb{T}}$  associated to the elliptic curve C should associate to the  $\mathbb{T}$ -equivariant spin bundle V=X a map

$$f: \operatorname{sp} E_{\mathbb{T}}(X) ! (T C) = W$$

which upon completion gives the map (1.13). Writing I(V) = f I and A(V) = f A, this map should have the following properties.

(1) There is a canonical isomorphism

$$I(V) = E_{\mathbb{T}}(V)$$

of line bundles over sp  $E_{\mathbb{T}}(X)$ .

(2) Suppose that  $V^{\emptyset}$  is another  $\mathbb{T}$ -equivariant spin bundle. If

$$c_2(V_{\mathbb{T}}) = c_2(V_{\mathbb{T}}^{\emptyset})$$

then  $A(V) = A(V^{\emptyset})$ ; indeed a  $\mathbb{T}$ -BOh8i structure on  $V - V^{\emptyset}$  determines a trivialization of  $A(V) = A(V^{\emptyset})^{-1}$ .

In the notation of the Theorem, let  $(V) = f(_d)$ . If  $V - V^{\emptyset}$  is a  $\mathbb{T}$ -BOh8i-bundle, then  $(V) = (V^{\emptyset})$  is a trivialization of

$$\frac{A(V) \quad I(V)}{A(V^{\emptyset}) \quad I(V^{\emptyset})} = \frac{E_{\mathbb{T}}(V)}{E_{\mathbb{T}}(V^{\emptyset})};$$

this is the equivariant sigma orientation for  $V - V^{\emptyset}$ . From this point of view, the sigma function always determines a trivialization of the line bundle A(V) I(V); when  $c_2(V) = 0$ , A(V) is trivial and so this gives a Thom class. The letter A stands for \anomaly".

Early versions of this paper were attempts to prove the Conjecture 1.14 for Grojnowski's  $E_{\mathbb{T}}$ , and then to deduce Theorem 1.10 from it. However, for reasons we explain in section 10, we were only occasionally able to convince even ourselves of those proofs. Eventually, detailed consideration of the consequences of the Conjecture led us to the formulae in section 5.4 and so to concrete proofs.

In section 10 we do construct the map in the Conjecture for a functor which captures the behavior of the stalks of Grojnowski's functor. The argument uses the same information we used in section 5.4 and section 8 to produce the equivariant Thom class. The functor we study in section 10 was also inspired by Greenlees's rational  $\mathbb{T}$ -equivariant elliptic spectra [10] and by Hopkins's work on characters in elliptic cohomology [12]. Indeed we hope that Greenlees's rational  $\mathbb{T}$ -equivariant elliptic spectra will admit a proof of the conjecture, and so give an account of the *rational* circle-equivariant sigma orientation.

The rest of the paper proceeds as follows. In section 2 we summarize some of the notation which recurs throughout the paper. We discuss complex-orientable cohomology theories in general and ordinary and elliptic cohomology theories in particular. In section 3 we state in a useful form some standard facts about  $\mathbb{T}$ -equivariant principal G-bundles.

In section 4 we interpret the analysis of section 3 in the presence of a (rational) complex-orientable cohomology theory. We begin section 5 with an interlude

(section 5.1) on degree-four characteristic classes. In section 5.2 we recall a result essentially due to [16], that a degree-four characteristic class  $2H^4(BG;\mathbb{Z})$  gives rise to a W-equivariant line bundle L() over (T-C). We de ne a theta function of level—for G to be a W-invariant holomorphic section of the line bundle L(); by the splitting principle, the Taylor series expansion of such a theta function de nes a characteristic class of principal G-bundles. The sigma function provides the most important examples for us, and so we discuss it in section 5.3.

Section 5.4 is the heart of the paper. In it we use the results of section  $3\mid 5.3$  to construct some holomorphic characteristic classes for  $\mathbb{T}$ -equivariant principal G-bundles which are the building blocks of the Thom classes in section 8 and section 9.

In section 6 we recall the construction of Grojnowski's analytic  $\mathbb{T}$ -equivariant elliptic cohomology associated to a lattice  $\mathbb{C}$ : In section 7 we review the equivariant elliptic cohomology of Thom complexes [19, 1], recalling what is involved in constructing a global section of  $E_{\mathbb{T}}(V)$ , where V is (virtual)  $\mathbb{T}$ -oriented vector bundle.

In section 9 we construct the equivariant sigma orientation, proving Theorem 1.10. In section 8 we prove the following related result. Let G be a spinor group, and let  $G^{\emptyset}$  be a simple and simply connected compact Lie group. Let V be a  $\mathbb{T}$ -equivariant G-bundle over a nite  $\mathbb{T}$ -CW complex X, and let  $V^{\emptyset}$  be a  $\mathbb{T}$ -equivariant  $G^{\emptyset}$ -bundle. Let

$$(V_{\mathbb{T}}) \ 2 \ E(X_{\mathbb{T}}^{V_{\mathbb{T}}})$$

be the Thom class given by the Weierstrass sigma function (see De nition 4.13). Suppose that  $^{\ell}$  is a degree-four characteristic classes for  $G^{\ell}$ , with the property that

$$c_2(V_{\mathbb{T}}) = {}^{\theta}(V_{\mathbb{T}}^{\theta})$$
:

Suppose that  $\ ^{\ell}$  is a theta function for  $\ G^{\ell}$  of level  $\ ^{\ell}.$ 

**Theorem 1.15** (8.6) A  $\mathbb{T}$ -orientation on V determines a canonical global section =  $(V; V^{\theta}; )$  of  $E_{\mathbb{T}}(V)^{-1}$ , whose value in  $E_{\mathbb{T}}(V)^{-1}_0$  is  ${}^{\theta}(V_{\mathbb{T}}^{\theta})$   $(V_{\mathbb{T}})^{-1}$ . The formation of V is natural in the sense if

$$g=f: W=Y ! V=X$$
  
 $g^{\theta}=f: W^{\theta}=Y ! V^{\theta}=X$ 

are pull-backs of vector bundles, then under the isomorphism

$$E_{\mathbb{T}}(q=f): E_{\mathbb{T}}(f) \ E_{\mathbb{T}}(V) = E_{\mathbb{T}}(W);$$

we have

$$E_{\mathbb{T}}(f)$$
  $(V; V^{\theta}; ) = (W; W^{\theta}; g):$ 

In particular, suppose that  $V^{\ell}$  is an equivariant  $Spin(2d^{\ell})$ -vector bundle over X, and V is an equivariant Spin(2d) vector bundle. Suppose that  $\ell$  is the character of a representation of  $LSpin(2d^{\ell})$  of level k: then it is a theta function of level  $kc_2$  for  $Spin(2d^{\ell})$ . If

$$c_2(V_{\mathbb{T}}) = kc_2(V_{\mathbb{T}}^{\theta})$$

then Theorem 1.15 gives a global section of  $E_{\mathbb{T}}(V)^{-1}$ . If X is a manifold and V is the tangent bundle of X, then the Pontrjagin-Thom construction for the map X:

$$(E_{\mathbb{T}}(\ ))\ E_{\mathbb{T}}(V)^{-1}\ !\ E_{\mathbb{T}}(\ )=O_{C}$$

of  $O_C$ -modules which takes to the equivariant Witten genus of V twisted by the characteristic class  ${}^{\ell}(V_{\mathbb{T}}^{\ell})$ . Since the global sections of  $O_C$  are the constants, we have the following result of Kefeng Liu [15].

**Corollary 1.16** *Under these conditions, the equivariant Witten genus of X twisted by*  $(V_{\mathbb{T}}^{\emptyset})$  *is constant.* 

**Remark 1.17** Liu states a condition on  $p_1$  instead of  $c_2$ .

If section 5.4 is the heart of the paper, then section 10 is the soul. There we discuss Conjecture 1.14, the study of which led to the results we report here. We give a re nement of the conjecture (Conjecture 10.1), and we explain how the arguments in this paper support it. We show how to construct the map of Conjecture 1.14 for a functor which captures the behavior of the stalks of Grojnowski's functor; the construction is essentially a \transfer formula" in the sense of [7]. We show that the nonequivariant version of the conjecture is true, and sheds light on the nonequivariant sigma orientation. Because the characters of representations of the loop group LG are sections of the line bundle A, it illuminates the relationship between the sigma orientation, equivariant elliptic cohomology, and representations of loop groups [5, 3].

#### 2 Notation

# 2.1 Abelian groups

Let  $\mathcal C$  be a category with  $\$ nite products. The category  $\$ A $\mathcal C$  of abelian groups in  $\mathcal C$  is an additive category. In fact  $\$ A $\mathcal C$  is tensored over the category of  $\$ nitely generated free abelian groups. That is, a  $\$ nitely generated free abelian group  $\$ F and an abelian group  $\$ X of  $\$ C determine (naturally in  $\$ F and  $\$ X) an object  $\$ F  $\$ X of  $\$ A $\mathcal C$ , with a natural isomorphism

$$AC[F \mid X; Y] = (abelian groups)[F; AC[X; Y]]$$

If A is an abelian group written additively, and M is an abelian group written multiplicatively, then we write  $m^a$  for the element a m of A M. Similarly, if  $M^{\ell}$  is an abelian group,  $u \ 2 \ M^{\ell}$ , and  $m \ 2 \ \text{hom}(M^{\ell}; M)$  then we may write  $u^m$  for m(u).

We write  $\mathbb{G}_{\partial}$  for the additive group, and  $\mathbb{G}_m$  for the multiplicative group.

# **2.2** Lie groups and the group $T \times X$

In general, the letter G will stand for a compact Lie group with maximal torus T with Weyl group W. We de ne

The complex numbers appear in this paper both as a ring and as an analytic variety. To avoid confusion we write  $\mathbb{A}^1_{\rm an}$  for the complex numbers regarded as an analytic variety. Similarly, we write  $\mathbb{G}^{\rm an}_a$  for  $\mathbb{A}^1_{\rm an}$  with its additive structure of abelian topological group. We write z for the standard coordinate on  $\mathbb{G}_a$  and also on  $\mathbb{A}^1$ ,  $\mathbb{A}^1_{\rm an}$ ,  $\mathbb{G}^{\rm an}_a$ , etc. We write  $\mathbb{G}^{\rm an}_m$  for  $(\mathbb{A}^1_{\rm an})$  with its multiplicative group structure. We set

If V is an open set in a complex analytic variety, then we write  $O_V$  for the sheaf of holomorphic functions on V.

If A is an abelian topological group and a 2 A, when we write a for the translation map; and if V A is an open set, then we write

**De nition 2.2** An open set U of C is *small* if it is connected and  $J^{-1}U$  is a union of connected components V with the property that

#### 2.4 Ringed spaces

Grojnowski's  $\mathbb{T}$ -equivariant elliptic cohomology is a contravariant functor

(see section 6 and [11, 19, 1]). At roughly the same time as [11], Ginzburg-Kapranov-Vasserot [9] proposed that the  $\mathbb{T}$ -equivariant elliptic cohomology associated to an elliptic curve C should be a *covariant* functor

We have found this point of view to be extremely helpful, and so we have adopted it in writing this paper.

# 2.5 Ordinary cohomology

If R is a commutative ring, let HR denote ordinary cohomology with coecients in R. If X is a space, then we write

for the scheme over spec R associated to the cohomology of X. We may also view sp HR(X) as the ringed space with underlying space  $\operatorname{spec}(HR^{\operatorname{even}}(X))$  and structure sheaf associated to

We shall write H for  $H\mathbb{C}$ , cohomology with complex coe cients.

#### 2.6 Equivariant cohomology

If X is a space with a circle action, sp  $HR(X_{\mathbb{T}})$  is a scheme over sp  $HR(B\mathbb{T})$ , which we denote sp HR(X): We choose a generator of the character group of  $\mathbb{T}$ , and write z for the resulting generator of  $H\mathbb{Z}^2(B\mathbb{T})$ ; this gives an isomorphism

$$sp HR(B\mathbb{T}) = (\mathbb{G}_a)_R \tag{2.6}$$

of group schemes over spec R: We shall use (2.6) to view sp  $HR(X_{\mathbb{T}})$  as a scheme over  $\mathbb{A}^1_R$ .

We recall [18] that equivariant cohomology satis es a localization theorem.

**Theorem 2.7** If X has the homotopy type of a nite  $\mathbb{T}$ -CW complex (e.g. if X is a compact  $\mathbb{T}$ -manifold), then the natural map

$$\operatorname{sp} H(X_{\mathbb{T}}^{\mathbb{T}}) \vdash \operatorname{sp} H(X_{\mathbb{T}})$$

induces an isomorphism over spec  $\mathbb{C}[z;z^{-1}]$  sp  $H(B\mathbb{T})$ .

#### Holomorphic cohomology

Let  $\mathbb{A}^1_{an}$  be the analytic complex plane, so  $\mathcal{O}_{\mathbb{A}^1_{an}}$  is the sheaf of holomorphic functions on  $\mathbb{C}$ . Because of the natural maps

$$\mathbb{A}^1_{\mathrm{an}} ! \mathbb{A}^1_{\mathbb{C}} ! \mathbb{A}^1 = \mathrm{sp} H\mathbb{Z}(B\mathbb{T})$$

We view H(X) as the structure sheaf of a ringed space (2.5) sp H(X) over  $\mathbb{A}^1_{an}$ , namely the pull-back in the diagram

### The stalk of holomorphic cohomology

Let

$$\mathbb{A}^1_{\mathrm{an};0} = \mathrm{spec}(O_{\mathbb{A}^1_{\mathrm{an}};0})$$

be the local scheme associated to the stalk of  $O_{\mathbb{A}^1_{an}}$  at the origin. The stalk of H(X) at the origin is

#### 2.7 Generalized cohomology

#### Even periodic ring spectra

A ring spectrum E will be called \even periodic" if  $_{\text{odd}}E = 0$  and  $_{2}E$  contains a unit of E.

If E is an even periodic ring spectrum, and if X is a space, then we shall write  $E \times X$  for the unreduced cohomology of X. As in [2], we write sp E(X) for the formal scheme

$$\operatorname{sp} E(X) = \operatorname{colim}_F \times \operatorname{spec} E^0 F$$

over  $S_E = \operatorname{spec} E^0(\ )$ ; the colimit is over the compact subsets of X.

An even periodic ring spectrum is always complex-orientable. In particular

$$P_E \stackrel{\text{def}}{=} \operatorname{sp} E(B\mathbb{T})$$

is a (commutative, one-dimensional) formal group over  $S_E$ . For example, let  $HP\mathbb{Z}$  denote periodic ordinary cohomology with integer coe cients. Then  $P_{HP\mathbb{Z}} = \mathfrak{G}_a$ .

#### **Borel cohomology**

If E is an even periodic ring spectrum, and X is a space with a circle action, then the projection

# 3 Principal bundles with an action of the circle

# 3.1 A-bundles over trivial A-spaces

Let A be a closed subgroup of the circle  $\mathbb{T}$ . Suppose that G is a *connected* compact Lie group with maximal torus T, and let : Q ! Y be a principal G-bundle over a connected space Y. Suppose that A acts on Q = Y, xing Y. The group of automorphisms of Q = Y is the group of sections  $((Q _G G^c) = Y)$ , and an action of A on Q = Y is equivalent to a section  $a : 2 ((Q _G hom[A; G^c]) = Y)$  (The notation  $G^c$  refers to G with G acting on it by conjugation).

Since G is connected and A is (topologically) cyclic, every G-orbit in hom[A; G] intersects hom[A; T] nontrivially: that is, the map

$$hom[A;T]$$
!  $hom[A;G^c]$ !  $hom[A;G^c]=G$ 

is surjective.

In particular hom[A;  $G^c$ ]=G is discrete. Its points label the connected components of Q G hom[A;  $G^c$ ] via the surjective map

$$Q \in \text{hom}[A; G^c] ! \text{hom}[A; G] = G$$

Since Y is connected, we may choose a homomorphism  $m \ 2 \ \text{hom}[A; T]$  such that, for all  $x \ 2 \ Y$ , there is a  $p \ 2 \ Q$  such that

$$a(x) = [p; m];$$

the square brackets indicate the class in the Borel construction of the element (p; m) 2 Q hom[A; G]. The choice of m determines p only up to the centralizer Z(m) in G of the homomorphism m.

**De nition 3.1** A *reduction* of the action of A on Q is a homomorphism

The terminology is justi ed by the following observation. Let

be the stabilizer of m. One sees that T is a maximal torus of Z(m), with Weyl group W(m).

**Example 3.3** Suppose that G = U(n) is the unitary group with its maximal torus  $T = (z_1, \ldots, z_n)$  of diagonal matrices, and suppose that  $A = \mathbb{T}$ . Every homomorphism

$$m: \mathbb{T} ! T$$

is conjugate in U(n) to one of the form

$$m(z) = (z^{m_1}, \dots, z^{m_1}, z^{m_2}, \dots, z^{m_2}, \dots, z^{m_r}, \dots, z^{m_r});$$

where  $m_i$  2  $\mathbb{Z}$ . Let  $d_j$  be the multiplicity of  $m_j$ ; then the centralizer is the block-diagonal matrix

$$Z(m) = \begin{pmatrix} 2 & & & & 3 \\ U(d_1) & & & & 5 \\ & & & U(d_r) \end{pmatrix}$$

with Weyl group

$$W(m) = d_1$$
  $d_r$   $n = W$ :

If V is a  $\mathbb{T}$ -equivariant complex vector bundle over a connected trivial  $\mathbb{T}$ -space Y, and if this m is a reduction of the action of  $\mathbb{T}$  on the principal bundle of V, then the reduction of the structure group to Z(m) corresponds to the decomposition of V as the direct sum

$$V = V(m_1) V(m_r);$$

where  $\mathbb{T}$  acts on the ber of  $V(m_i)$  by the character  $z^{m_j}$ .

The composition



is a group homomorphism, and so we have a map

The following Lemma will be used directly to prove Lemma 5.5, a calculation of degree-four characteristic classes. Moreover, the algebro-geometric form of this diagram after applying a complex-orientable cohomology theory (see Lemma 4.2) captures the essential point of the \transfer argument" of [7], as we explain in Remark 10.7.

#### **Lemma 3.4** (1) The diagram



**Proof** The rst part is easy. For the second part, it su ces to construct a map of principal Z(m)-bundles over BA BZ(m). The map

factors through EA  $_AEZ(m)$ , and gives the desired map. (Note that the map Eg(m) is obtained by constructing EA and EZ(m) functorially as spaces with actions on the same side, say the left. In forming EA  $_AEZ(m)$ , one makes A act on the right of EA by the inverse.)

If  $m^{\emptyset}: A ! T$  is another reduction of the action of A on Q, then m and  $m^{\emptyset}$  di er by conjugation in G, and we have for some g in G a commutative diagram



#### 3.2 The case of a connected centralizer

**Lemma 3.6** If the centralizer Z(m) is connected, then the element g in the diagram (3.5) may be taken to be in the normalizer  $N_GT$  of T in G.

**Proof** Let *g 2 G* be such that

$$c_a m = m^{\theta}$$

Then  $m^{\ell}(A) = c_g(T) \setminus T$ , so both T and  $c_g(T)$  are maximal tori in  $Z(m^{\ell})$ . Since  $Z(m^{\ell})$  is connected, there is an element  $h \ 2 \ Z(m^{\ell})$  such that

$$c_h c_q(T) = T$$
;

so  $hg \ 2 \ N_G T$ . Since  $h \ 2 \ Z(m^{\emptyset})$ , we have

$$m^{\theta} = c_h m^{\theta} = c_h c_g m$$
:

Example 3.3 shows that Z(m) is connected if G is a unitary group. Bott and Samelson have shown ([6]; see Proposition 10.2 of [7]) that Z(m) is connected if G is a spinor group. Indeed they prove the following.

**Lemma 3.7** If G is simple and simply connected then the centralizer Z(m) is connected.

#### 3.3 Nested xed-point sets

If F  $Y^B$  is a connected component of the subspace of Y xed by the action of B, then we may choose a reduction

# 4 Rational cohomology of principal bundles with compact connected structure group

Let E be an *rational* even periodic ring spectrum. Let G be a connected compact Lie group. Let T be a maximal torus of G, with Weyl group W. The natural isomorphism

$$T \quad \mathbb{T} ! T$$

induces a W-equivariant isomorphism

$$T P_E = T \operatorname{sp} E(B\mathbb{T}) = \operatorname{sp} E(BT)$$

of formal groups over  $S_E$ . Moreover [4] the natural map

$$\operatorname{sp} E(BT) = W ! \operatorname{sp} E(BG)$$

is an isomorphism. We shall repeatedly use the resulting isomorphism

$$\operatorname{sp} E(BG) = (T P_E) = W$$

For example, a principal G-bundle Q over X is classified by a map

# 4.1 Periodic cohomology of circle-equivariant principal bundles

We interpret the analysis of section 3 in E-theory. Suppose that G is a connected compact Lie group, and that Q is a  $\mathbb{T}$ -equivariant principal G-bundle over a connected  $\mathbb{T}$ -space Y. Suppose that a closed subgroup A of the circle acts trivially on Y. Suppose that

In E cohomology, Lemma 3.4 implies the following result. It is used in the case  $A = \mathbb{T}$  to construct the commutative diagram (8.2) and so prove Lemma 8.4. It is also implies the commutativity of the diagram (10.6), which captures the essence of the \transfer formula" of Bott-Taubes [7]; see Remark 10.7.

### 4.2 Holomorphic characteristic classes

Let f be a W-invariant holomorphic function on T  $\mathbb{G}_a^{\mathrm{an}}$ . By the splitting principle, the Taylor expansion of f at the origin de nes a class in HP(BG). Suppose that Q is a principal G-bundle over X, with the property that  $Q_{\mathbb{T}}$  is a principal G-bundle over  $X_{\mathbb{T}}$ . Then we get a class

# 5 Degree-four characteristic classes and theta functions

#### 5.1 Degree-four characteristic classes

If G is a connected compact Lie group, then by the splitting principle the natural maps

Let  $m \ 2 \ T$  be a reduction of the action of  $\mathbb{T}$  on Q = Y. Then Q(m) is a principal Z(m)-bundle over Y, and we have the following.

#### 5.2 Theta functions

**Remark 5.13** Lemma 4.3 implies that a theta function for G gives a holomorphic characteristic class for principal *G*-bundles.

**Remark 5.14** There is a good deal of redundancy in the de nition. Looijenga studies formal series of the form (5.11) which transform according to (5.12). One has to be careful to identify a group formal series which is closed under the operations implied by (5.12). If is positive de nite, then every such formal theta function de nes a holomorphic function of  $(z_i)$  (see [16]).

#### **5.3** The sigma function and representations of LSpin(2d)

If G is a simple and simply connected Lie group, then there is a unique generator of  $H^4(BG;\mathbb{Z})=\mathbb{Z}$  such that the associated pairing I is positive de nite. If V is a representation of LG of level k in the sense of [17], then its character is a theta function for G of level K [14]. The most important example for us is the representation of LSpin(2d) whose character is the Euler class of the sigma orientation (4.13); it is a theta function associated to the characteristic class  $C_2$  of Spin(2d).

It is useful to be more explicit about this Euler class. As in Example 5.6, let  $T_{SO(2d)}$  be the image under the map U(d) ! SO(2d) of the torus of diagonal matrices. For  $u = (u_1; \dots; u_d)$  2 T write

$$d(u) = \bigvee_{i=1}^{d} (u_i): \tag{5.15}$$

The product expression (5.15) and the fact (4.11a) that is odd imply that  $_d(u^w) = _d(u)$  for  $w \ 2 \ W$ , and so  $_d$  is a W-invariant function on  $T \ \mathbb{G}^{\mathrm{an}}_a$  (with zeroes precisely at the points T ). By Lemma 4.3 it de nes a holomorphic characteristic class for oriented vector bundles of rank 2d. If V is such a vector bundle, then  $(V) = _d(V)$ :

The fractional powers of u in the expression (4.9) for prevent  $_d$  from being a theta function for SO(2d), but if G = Spin(2d) then the formula

shows that  $_d 2(\mathbb{Z}[\hat{T}])[q]$ . The formula (4.11c) implies that, if I and  $_d$  are the pairing and quadratic form associated to the generator  $c_2 2H^4(BG;\mathbb{Z})$  as in Example 5.6, then

so d is a theta function for Spin(2d) of level  $c_2$ . Up to the factor  $\binom{\bigcirc}{n}(1-q^n)^{2d}$ , it is the character of an irreducible representation of LSpin(2d) of level 1 [14, 17, 15].

#### 5.4 A useful holomorphic characteristic class

Suppose that Q is a  $\mathbb{T}$ -equivariant principal G-bundle over a connected  $\mathbb{T}$ -space Y. Suppose that  $\mathbb{T}[n]$   $\mathbb{T}$  acts trivially on Y. Let

**Lemma 5.19** F is invariant under W(m).

is an  $n^{\text{th}}$  root of unity which is independent of the choice of lift of a; in fact it is the Weil pairing of a and  $q^{\frac{1}{n}}$  in the curve C. Because it is an  $n^{\text{th}}$  root of unity, the quantity

$$W(a;q^{\frac{1}{n}}) \stackrel{(m)}{=} \stackrel{\text{def}}{=} W(a;q^{\frac{1}{n}}) \stackrel{(\overline{m})}{=}$$

is independent of the lift  $\overline{m}$  of m. Using the functional equation for (5.12) it is straightforward to check the following.

Lemma 5.19 implies that the Taylor series expansion of  $F(\ ; m; \overline{a})$  de nes a class in  $\hat{H}(BZ(m)) = \hat{H}(BT)^{W(m)}$ , which we also denote  $F(\ ; m; \overline{a})$ . Let  $(Q; m; \overline{a}) = 2 H(Y; \mathbb{A}^1_{an})$  be the holomorphic cohomology class given by the formula

$$(Q; m; \overline{a}) = Q(m)_{\mathbb{T}} F(; m; \overline{a})$$
 (5.21)

(using Lemma 4.3 to conclude that the class  $(Q; m; \overline{a})$  is in fact holomorphic).

**Lemma 5.22** If the centralizer Z(m) is connected, for example if G is unitary or spin, then the class  $(Q; m; \overline{a})$  is independent of the reduction m of the action of  $\mathbb{T}[n]$  on Q=Y.

**Proof** Let  $m^{\emptyset}$  be another reduction of the action of  $\mathbb{T}[n]$  on Q=Y. By Lemma 3.6, there is an element  $w \ 2 \ W$  such that

The results of this section justify the following.

**De nition 5.23** Suppose that Q is a  $\mathbb{T}$ -equivariant principal G-bundle over a connected  $\mathbb{T}$ -space Y on which  $\mathbb{T}[n]$  acts trivially. Suppose that for some (equivalently every) reduction

$$m: \mathbb{T}[n] ! T$$

of the action of  $\mathbb{T}[n]$  on Q=Y, the centralizer Z(m) is connected. Let C be the elliptic curve  $\mathbb{G}_a^{\mathrm{an}}=2$   $i\mathbb{Z}+2$   $i\mathbb{Z}$ . Let a be a point of C of order n. Let b be a theta function for G of level C, and let  $\overline{C}$  be a point of  $\mathbb{A}_{\mathrm{an}}^1$  whose image in C is a. We de ne  $(C;\overline{C})$  2  $H(Y;\mathbb{A}_{\mathrm{an}}^1)$  to be the holomorphic cohomology class

$$(Q; \overline{a}) = (Q; m; \overline{a}); \tag{5.24}$$

in particular this class does not depend on the choice of m.

**Lemma 5.25** If  $\overline{a}^{0} = \overline{a} + 2$  is is another lift of a, then


$$(Q;\overline{a}^{0}) = W(a;q^{\frac{1}{n}}) \quad (m) \quad (Q;\overline{a}); \tag{5.26}$$

again this class does not depend on the choice of m.

An important case of the preceding constructions is that G = Spin(2d), and d is the character of the basic representation of LG as in section 5.3. Let p:G! SO(2d) be standard the double cover. Let P=Y be the resulting  $\mathbb{T}$ -equivariant SO(2d)-bundle over Y, and let V be the associated vector bundle. We recall from [7] that Lemma 3.7 implies that the sub-vector bundle  $V^{\mathbb{T}[n]}$  is orientable. Explicitly, if m is a reduction of the action of  $\mathbb{T}[n]$  on Q=Y, then pm is a reduction of the action of  $\mathbb{T}[n]$  on P=Y. If  $V^{\mathbb{T}[n]}$  has rank 2k, then the map

$$Y \vdash BO(2k)$$

classifying  $V^{\mathbb{T}[n]}$  factors through the map  $Y \not = BZ(pm)$  classifying P(pm), and we have the solid diagram



Since (by Lemma 3.7) the centralizer Z(m) is connected, there is a dotted arrow making the diagram commute. In other words,  $V^{\mathbb{T}[n]}$  is orientable, and a choice of orientation  $(V^{\mathbb{T}[n]})$  determines a map

such that fQ(m) classi es  $(V^{\mathbb{T}[n]}; (V^{\mathbb{T}[n]}))$ . In other words, Lemma 3.7 implies the following result (as I learned from [7]).

**Lemma 5.27** If V is a  $\mathbb{T}$ -equivariant Spin(2d)-vector bundle, then it is  $\mathbb{T}$ -orientable.

Let  $_k \ 2 \ \hat{H}(BSO(2k))$  be the characteristic class associated to the sigma function as in section 5.3. We then have two W(m)-invariant holomorphic functions on  $T = \mathbb{G}_a^{\mathrm{an}}$ . One is  $f = _k$ , and the other is  $F(\cdot;m;\overline{a})$ .

#### Lemma 5.28 The ratio

$$R = \frac{f_k}{F(a; m; \overline{a})}$$

is a W(m)-invariant unit of  $(O_{\mathcal{T}} \otimes_{a}^{an})_{0}$ .

**Proof** The poles of R occur at zeroes of F: Using the standard maximal torus of SO(2d) we may write a typical element of T  $\mathbb{G}_m^{an}$  as

$$(u_1; \dots; u_d) \ 2 (\mathbb{G}_m^{\mathrm{an}})^d = T \quad \mathbb{G}_m^{\mathrm{an}}$$

In these terms, a lift  $\overline{m}$  of m is of the form

$$u^{\overline{m}} = (u^{m_1}; \dots; u^{m_d})$$

for some integers  $m_1 : : : : m_d$ . We have

$$F(\underline{u}; m; \overline{a}) = u^{\frac{k}{n} \hat{\uparrow}(\overline{m})} \xrightarrow{k} (\overline{m})^{\gamma d} (u_j m_j):$$

The product of sigma functions contributes a zero near z=0 if and only if  $m_j a=0$  in C. Let  $j_1,\ldots,j_k 2$   $f_1,\ldots,dg$  be the indices such that  $m_{j_i}a=0$  in C; then

$$f \quad k = \bigvee_{i=1}^{k} (u_{j_i} \quad m_{j_i}):$$

So the zeroes of  $f_{k}$  precisely cancel those of  $F(g, m; \overline{a})$ .

Lemmas 4.3 and 5.28 together imply that R de nes a holomorphic characteristic class for Z(m)-bundles.

**Corollary 5.29** The holomorphic characteristic class

$$R(V; V^{\mathbb{T}[n]}; (V^{\mathbb{T}[n]}); \overline{a}) \stackrel{\text{def}}{=} Q(m)_{\mathbb{T}} R \ 2 \ (H(Y)_0)$$

is independent of the reduction m, and satis es

$$e\ (V_{\mathbb{T}}^{\mathbb{T}[n]};\ (V^{\mathbb{T}[n]})) = R(V;V^{\mathbb{T}[n]};\ (V^{\mathbb{T}[n]});\overline{a})\ (V;\overline{a}): \qquad \qquad \Box$$

# 6 Equivariant elliptic cohomology

# 6.1 Adapted open cover of an elliptic curve

If X is a  $\mathbb{T}$ -space and if a is a point of C, then we de ne  $X^a = \begin{array}{cc} X^{\mathbb{T}[k]} & a \text{ is of order exactly } k \text{ in } C \\ X^{\mathbb{T}} & \text{otherwise:} \end{array}$ 

Let N 1 be an integer.

**De nition 6.1** A point a 2 C is special for X if  $X^a \in X^T$ .

If V is a  $\mathbb{T}$ -bundle over a  $\mathbb{T}$ -space X, then it is convenient to consider a few additional points to be special. Suppose that F is a component of  $X^{\mathbb{T}}$  and

$$m: \mathbb{T} ! T$$

is a reduction of the action of  $\mathbb T$  on the principal bundle associated to  $\mathcal V$ . If we choose an isomorphism

$$T = \mathbb{Z}^r$$
:

then we may view m as an array of integers  $(m_1; m_2; \dots; m_r)$ . These integers are called the *exponents* or *rotation numbers* of V at F. Let  $V^+$  denote the one-point compactic cation of V.

**De nition 6.2** A point a in C is *special* for V if it is special for  $V^+$  or if for some component F of  $X^{\mathbb{T}}$  there is a rotation number  $m_j$  of V such that  $m_j a = 0$ .

In either case, if X is a nite  $\mathbb{T}$ -CW complex, then the set of special points is a nite subset of the torsion subgroup of C.

**De nition 6.3** An indexed open cover  $fU_ag_{a2C}$  of C is adapted to X or V if it satis es the following.

- 1) a is contained in  $U_a$  for all  $a \ge C$ .
- 2) If a is special and  $a \in b$ , then  $a \not a \cup U_a \setminus U_b$ .
- 3) If a and b are both special and  $a \in b$ , then the intersection  $U_a \setminus U_b$  is empty.
- 4) If b is ordinary, then  $U_a \setminus U_b$  is non-empty for at most one special a.
- 5) Each  $U_a$  is small (2.2).

**Lemma 6.4** Let X be a nite  $\mathbb{T}$ -CW complex. Then C has an adapted open cover, and any two adapted open covers have a common re nement.  $\square$ 

## 6.2 Complex elliptic cohomology

Let

$$\stackrel{\triangle}{E} \stackrel{\text{def}}{=} (HP; C; b^{-1}) = (HP; C; \log_{L})$$

be the elliptic spectrum associated to the elliptic curve C (see (2.10)). Note that this is just a form of ordinary cohomology. The hat in the notation indicates that this is a completion of the associated holomorphic cohomology. Namely, suppose that U = C is a small open neighborhood of the identity in C. Suppose that  $V = \mathbb{A}^1_{an}$  is the component of  $\mathcal{F}^{-1}U$  containing the origin. Let  $\mathrm{Sp} E(X_{\mathbb{T}})j_U = (U; E(X_{\mathbb{T}})j_U)$  be the ringed space defined as the pull-back in the diagram

$$\operatorname{sp} E(X_{\mathbb{T}}) j_{U} \longrightarrow \operatorname{sp} H(X) j_{V} \qquad (6.5)$$

$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$

$$U \xrightarrow{(\} j_{V})^{-1}} V$$

The diagram (2.9) shows that sp  $\hat{E}(X_T)$  and sp  $E(X_T)j_U$  are related by the formula

$$\operatorname{sp} \hat{E}(X_{\mathbb{T}}) = (\operatorname{sp} E(X_{\mathbb{T}})j_U)_0^{\hat{}}:$$

## 6.3 Equivariant elliptic cohomology

Grojnowski's circle-equivariant extension of  $\not E$  is a contravariant functor associating to a compact  $\mathbb T$ -manifold X a  $\mathbb Z$ -2-graded  $\mathcal O_{\mathcal C}$ -algebra  $\mathcal E_{\mathbb T}(X)$ , with the property that

$$E_{\mathbb{T}}(\ )=O_{\mathbb{C}}$$

It is equipped with a natural isomorphism

$$\stackrel{\triangle}{E}(X_{\mathbb{T}}) \stackrel{A(X)}{\stackrel{=}{=}} (E_{\mathbb{T}}(X))_{0}^{\hat{}};$$

such that

$$A(\ )=\log_!:(O_C)_0^{^{^{\prime}}}=\dot{E}(B\mathbb{T}):$$

We shall write sp  $E_{\mathbb{T}}(X)$  for the ringed space  $(C; E_{\mathbb{T}}(X))$  (see (2.5)). We take this opportunity to phrase the account in [1] of the construction of  $E_{\mathbb{T}}(X)$  as the construction of a covariant functor

$$X \not I \operatorname{sp} E_{\mathbb{T}}(X)$$

from  $\$ nite  $\$ T-CW complexes to ringed spaces (2.5) over  $\$ C, equipped with an identication

If  $X = (X; O_X)$  is a ringed space and U is an open set of X, then we may write X(U) in place of  $O_X(U)$ .

Let  $fU_ag_{a2C}$  be an adapted open cover of C. For each a2C, we make a ringed space sp  $E_{\mathbb{T};a}(X) = (U_a; E_{\mathbb{T};a}(X))$  over  $U_a$  as the pull back in the diagram

$$\operatorname{sp} E_{\mathbb{T};a}(X) \longrightarrow \operatorname{sp} E(X_{\mathbb{T}}) j_{U_{a}-a} \longrightarrow \operatorname{sp} H(X) j_{V}$$

As in (6.5), V is the component of  $f^{-1}(U_a - a)$  containing the origin. In other words, let  $V_a = f^{-1}(U_a)$  be the component containing the origin. For  $U = U_a$  let  $V = V_a \setminus f^{-1}(U - a)$ , and let

$$E_{\mathbb{T}:a}(X)(U) = H(X^a; V);$$

If  $a \in b$  and  $U_a \setminus U_b$  is not empty, then by the de nition (6.3) of an adapted cover, at least one of  $U_a$  and  $U_b$ , suppose  $U_b$ , contains no special point. In particular we have  $X^b = X^{\mathbb{T}}$  and so an isomorphism

$$\operatorname{sp} E(X_{\mathbb{T}}^b) j_U = \operatorname{sp} E(X^b) \quad U$$

i.e.

$$E(X_{\mathbb{T}}^b)_{\mathbb{C}[z]} O_U = E(X^b)_{\mathbb{C}} O_U$$

for any small neighborhood U of the origin.

**Lemma 6.8** If  $a \notin b$ ,  $U = U_a \setminus U_b$ , and b is not special, then the inclusion

$$i: X^b \vdash X^a$$

induces an isomorphism



**Proof** If a is not special, then  $X^a = X^b$  and the result is obvious. If a is special, then it is not contained in U (by the de nition of an adapted cover), and so 0 is not contained in U - a. The localization theorem (2.7) gives the result.

Let  $U = U_a \setminus U_b$ . We de ne

We shall write sp  $E_{\mathbb{T}}(X)$  for the ringed space over C, and  $E_{\mathbb{T}}(X)$  for its structure sheaf. One then has the following ([11]; for a published account see [19]).

**Proposition 6.10** sp  $E_{\mathbb{T}}(X)$  is a ringed space over C, which is independent up to canonical isomorphism of the choice of adapted open cover.

# 7 Equivariant elliptic cohomology of Thom spaces

Suppose that V is a  $\mathbb{T}$ -equivariant vector bundle over X, and let  $V_0$  be the complement of the zero section of V. We abbreviate as

$$E_{\mathbb{T}}(V) = E_{\mathbb{T}}(V; V_0) \tag{7.1}$$

the  $E_{\mathbb{T}}(X)$ -module associated to the reduced  $E_{\mathbb{T}}$ -cohomology of the Thom space of V. Explicitly, for each point  $a \ 2 \ C$  we de ne a sheaf  $E_{\mathbb{T};a}(V)$  of  $E_{\mathbb{T};a}(X)$ -modules as the pull-back

$$E_{\mathbb{T};a}(V) \longrightarrow E(V_{\mathbb{T}}^{a})j_{U_{a}-a}$$

For a special and b not with  $U_a \setminus U_b$  non-empty, the isomorphism

$$V_{ab}: E_{\mathbb{T};a}(V)j_{U_a \setminus U_b} = E_{\mathbb{T};b}(V)j_{U_a \setminus U_b}$$

is given by

$$E(V_{\mathbb{T}}^{a})j_{U_{ab}-a}(U-a) \stackrel{!}{=} E(V_{\mathbb{T}}^{b})j_{U_{ab}-a}(U-a) = E(V^{b}) \underset{\mathbb{C}}{\circ} O(U-a) \stackrel{b-a}{=} E(V^{b})$$

where  $U_{ab} = U_a \setminus U_b$ ; U denotes an open subset of  $U_{ab}$ , and we have omitted a pullback (7.2) at either end.

**De nition 7.3** The vector bundle V is  $\mathbb{T}$ -orientable if for each closed subgroup A  $\mathbb{T}$ , the xed bundle  $V^A$  over  $X^A$  is orientable. A  $\mathbb{T}$ -orientation on V is a choice  $(V^A)$  of orientation on  $V^A$  for each A.

**Lemma 7.4** If V is a  $\mathbb{T}$ -orientable vector bundle over X, then  $E_{\mathbb{T}}(V)$  is a line bundle over sp  $E_{\mathbb{T}}(X)$ , that is,  $E_{\mathbb{T}}(V)$  is an invertible  $E_{\mathbb{T}}(X)$ -module.

**Proof** If V is  $\mathbb{T}$ -orientable, then the Thom isomorphism in ordinary cohomology implies that each  $E_{\mathbb{T};a}(V)$  is an invertible  $E_{\mathbb{T};a}(X)$ -module.

We recall from [19, 1] the construction of an explicit cocycle for this line bundle. Let be a multiplicative analytic orientation (4.5), and let be a  $\mathbb{T}$ -orientation on V.

**De nition 7.5** An indexed open cover  $fU_ag_{a2C}$  of C is adapted to  $(V; \; ; \;)$  if it is adapted to V (see De nition 6.3), and if for every point  $a \; 2 \; C$ , the equivariant Thom class  $(V_{\mathbb{T}}^a; \;)$  induces an isomorphism

$$H(X; U_a - a) + H(V^a; U_a - a)$$
:

Corollary 4.7 implies that C has an indexed open cover adapted to  $(V; \cdot; \cdot)$ . Choose such a cover. Suppose that a; b are two points of C, such that  $U = U_a \setminus U_b$  is non-empty: we may suppose that a = b or that b is not special. Consider the case that b is not special. Let  $\overline{U}_a = \mathbb{A}^1_{an}$  be the component of the preimage of  $U_a - a$  containing the origin, and let

$$\{j_{\overline{U}_a}: \overline{U}_a ! U_a - a\}$$

be the induced isomorphism. Let  $\overline{U}$   $\overline{U}_a$  be the preimage of U. Let

$$j:(V^b;V_0^b)!(V^a;V_0^a)$$

be the natural map. The Localization Theorem (Theorem 2.7) implies that the ratio of Euler classes

$$e(V^a; V^b;) \stackrel{\text{def}}{=} \frac{j((V^a)_{\mathbb{T}}; (V^a))}{((V^b)_{\mathbb{T}}; (V^b))}$$

is a unit of  $H(X^{\mathbb{T}}; \overline{U})$ .

Recall that there are tautological isomorphisms

$$E_{\mathbb{T};a}(X)(U) \stackrel{f}{=} E(X^a_{\mathbb{T}})j_{U-a}(U-a) \stackrel{(\mathcal{J}_{\overline{U}})}{=} H(X^a;\overline{U})$$

Note that e(a;b;) = 1 if neither a nor b is special; we also set

for all a. It is easy to check that

if  $U_a \setminus U_b \setminus U_c$  is non-empty (since in that case at least two of a;b;c are ordinary). Thus the e (a;b) de ne a cohomology class  $[\ ;V;\ ]\ 2\ H^1(C;E_{\mathbb{T}}(X)\ )$ . Let  $E_{\mathbb{T}}(X)^{[\ ;V;\ ]}$  be the resulting invertible sheaf of  $E_{\mathbb{T}}(X)$ -modules over C. By construction we have the

#### **Proposition 7.8** The Thom isomorphism induces an isomorphism

As mentioned in the introduction, if  $f(W) = (V_0, V_1)$  is a pair of  $\mathbb{T}$ -oriented vector bundles, then we extend the notation (7.1) by de ning  $E_{\mathbb{T}}(W)$  to be the invertible sheaf

# 8 A Thom class

# 8.1 Equivariant elliptic cohomology of principal bundles

as in (4.1).

If F is a connected component of  $X^{\mathbb{T}}$ , and if



In writing this paper, we were guided by the idea (Conjecture 10.1) that there should be a canonical map sp  $E_{\mathbb{T}}(Q)$  making the whole diagram (8.3) commute. We shall return to that question in section 10, discussing both why such a map would be a good thing and why it is discuss to construct. For now we merely observe that the definition of sp  $E_{\mathbb{T}}(Q(m))$  implies the following.

# 9 The sigma orientation

Recall ([6, 7]; see Lemma 5.27) that each  $V_i$  is  $\mathbb{T}$ -orientable.

**Theorem 9.1** A  $\mathbb{T}$ -orientation on  $V_0$  and  $V_1$  determines a canonical trivialization (V) = (V) of  $E_{\mathbb{T}}(V)$ , whose value in  $E_{\mathbb{T}}(V)^{\wedge}_0 = \mathcal{H}((X_{\mathbb{T}})^{V_{\mathbb{T}}})$  is  $(V_{\mathbb{T}})$  (see De nition 4.13). The association  $V \mathcal{V}$  (V) is stable, natural, and exponential in the sense described in Theorem 1.10.

**Proof** The proof proceeds much as the proof of Theorem 8.6: to construct (V) it is equivalent to give a section of  $E_{\mathbb{T}}(X)^{[-|V|]}$  whose value in

$$(\}j_{W}) \quad {}_{a} \quad {}_{a} \stackrel{\text{def}}{=} \frac{R(V_{1}; V_{1}^{a}; (V_{1}^{a}); \overline{a})}{R(V_{0}; V_{0}^{a}; (V_{0}^{a}); \overline{a})};$$

where  $W = \}^{-1}(U_a)$  is the component containing the origin, and R is the characteristic class defined in Corollary 5.29. As in Lemma 8.12,  $_a$  is independent of the lift  $\overline{a}$ . In this case, additionally, Corollary 5.29 implies that  $_a$  is a *unit*, i.e. an element of  $E_{\mathbb{T};a}(X)(U_a)$ .

The same argument as in the proof of Lemma 8.13 shows that the sections  $_a$  for  $a \ 2 \ C$  assemble into a global section of  $E_{\mathbb{T}}(X)^{[-|V|]}$ , which is a trivialization because it is so on each  $U_a$ .

The fact that the section (V) is independent of the choice of  $V_i$ , as well as the fact that  $(V \ V^{\emptyset}) = (V) \ (V^{\emptyset})$  follows from de nition of (V) and the equation

$$(V \quad V^{\ell}) = (V) \quad (V^{\ell})$$
:

The naturality under change of base is clear from the construction.

# 10 A conceptual construction of the equivariant sigma orientation

This section is devoted to a discussion of the following elaboration of Conjecture 1.14.

**Conjecture 10.1** Equivariant elliptic cohomology ought to have the following feature. Suppose that Q is a  $\mathbb{T}$ -equivariant principal G-bundle over a  $\mathbb{T}$ -space X. Then there is a canonical map

$$\operatorname{sp} E_{\mathbb{T}}(X) \xrightarrow{\operatorname{sp} E_{\mathbb{T}}(Q)} (T \quad C) = W$$

making the diagram

$$\operatorname{sp} E(X_{\mathbb{T}}) \xrightarrow{\operatorname{sp} E(Q_{\mathbb{T}})} (T \quad \mathcal{C}) = W$$

$$\operatorname{sp} E_{\mathbb{T}}(X) \xrightarrow{\operatorname{sp} E_{\mathbb{T}}(Q)} (T \quad C) = W$$

commute and having all the properties listed in Conjecture 1.14. Moreover, for all components F of  $X^{\mathbb{T}}$  and all reductions

$$m: \mathbb{T} ! T$$

of the action of  $\mathbb{T}$  on  $\mathcal{Q}_{j_F}$ , the diagram (8.3) should commute.

# 10.1 Why the conjecture should be true, and why it is nevertheless dicult to prove

As explained in the introduction, the conjecture gives an elegant description of the equivariant sigma orientation, which even illuminates the non-equivariant case.

Although we have stated a conjecture, it is really a proposal of structure which should be sought in *some* equivariant elliptic cohomology theory. How dicult it is to establish the conjecture depends on your ontology. Given a fully developed theory of equivariant elliptic cohomology as proposed by Ginzburg-Kapranov-Vasserot, it is not dicult at least to construct the map sp  $E_{\mathbb{T}}(Q)$ .

To see this, recall that Ginzburg, Kapranov, and Vasserot have proposed that equivariant elliptic cohomology for the curve  $\mathcal C$  and the (compact connected Lie) group  $\mathcal G$  should be a covariant functor

$$GKV_G(-): (G\{\text{spaces}) ! \text{ (schemes over } (T C)=W):$$

If Q is a  $\mathbb{T}$ -equivariant principal G-bundle over X, then the  $(\mathbb{T} \ G)$ -equivariant elliptic cohomology of Q should be a scheme

$$GKV_{\mathbb{T}}$$
  $_{G}(Q)$  !  $C$   $(T$   $C=W)$ 

over both C (via the  $\mathbb{T}$ -action) and T C=W (via the G-action). Now G acts freely on Q with quotient X, so one expects that

$$GKV_{\mathbb{T}}$$
  $_{G}(Q) = GKV_{\mathbb{T}}(X)$ :

Combining these observations leads to the prediction that a  $\mathbb{T}$ -equivariant principal G-bundle over X should give rise to the map

$$GKV_{\mathbb{T}}(X) \xrightarrow{GKV_{\mathbb{T}}(Q)} (T \quad C)=W$$
:

There are two problems with this proposal. First, we have in this paper described only  $\mathbb{T}$ -equivariant elliptic cohomology. It may not be discult to resolve this problem: it is not so discult to imagine an analogous construction of G-equivariant elliptic cohomology, and indeed Grojnowski does so in [11]. That leaves the second problem, that the underlying space of Grojnowski's functor is always C: if

$$: GKV_{\mathbb{T}}(X) ! C$$

is the structural map associated to an elliptic cohomology which is proposed by Ginzburg-Kapranov-Vasserot, then we have worked in this paper with the sheaf

$$E_{\mathbb{T}}(X) = O_{GKV_{\mathbb{T}}(X)}$$
:

To see why this is a problem, note that in order to construct a map

$$\operatorname{sp} E_{\mathbb{T}}(Q) : \operatorname{sp} E_{\mathbb{T}}(X) ! T C=W$$

we must in particular construct a map of topological spaces

$$C! (T C)=W$$
: (10.2)

If  $X^{\mathbb{T}}$  is non-empty, then sp  $E_{\mathbb{T}}(X^T) = X^{\mathbb{T}}$  C, and for each connected component F of  $X^{\mathbb{T}}$ , a reduction of the action of  $\mathbb{T}$  on  $\mathcal{O}_{j_F}$  gives a map

and so one has a place to start. But it is perfectly possible that  $X^{\mathbb{T}}$  is empty, and then it is not clear how to proceed. For example, since

$$\operatorname{sp} \hat{E}((B(\mathbb{Z}=N))) = \mathcal{O}[N]$$

one expects that

$$GKV_{\mathbb{T}}(\mathbb{T}=\mathbb{T}[N]) = GKV_{\mathbb{T}[N]}() = C[N]:$$

We shall cite three facts to support our conjecture. First, if  $F X^{\mathbb{T}}$  is a component of the xed set, and if

$$m: \mathbb{T} ! T$$

is a reduction of the action of  $\mathbb{T}$  on F, then using the map of diagram (8.3)

$$\operatorname{sp} E_{\mathbb{T}}(Q(m)) = \operatorname{sp} \hat{E}(Q(m)) + m : \operatorname{sp} E_{\mathbb{T}}(F) ! T C=W(m) ! T C=W(m)$$

it is easy to check that

$$A(V)j_{\operatorname{sp} E_{\mathbb{T}}(X^{\mathbb{T}})} = A(V^{\emptyset})j_{\operatorname{sp} E_{\mathbb{T}}(X^{\mathbb{T}})}$$

when

$$c_2(V_{\mathbb{T}}) = c_2(V_{\mathbb{T}}^{\ell})$$
:

this is the content of the proof of Lemma 8.9.

Second, the isomorphism

$$E_{\mathbb{T}}(V) = I(V)$$

of the conjecture corresponds to the fact that the sigma function gives a trivialization of  $E_{\mathbb{T}}(V)$  in Theorem 9.1.

Finally, we construct a map E(Q) for a stylized functor E, which is not quite Grojnowski's elliptic cohomology, but captures its behavior on stalks. We simply throw away the points of C for which we have no instructions for constructing a map (10.2). The functor E is inspired by the *rational*  $\mathbb{T}$ -equivariant elliptic spectra of Greenlees [10] and by Hopkins's study of characters and elliptic cohomology [12].

Recall that R denotes the category of ringed spaces. Let S be the category in which the objects are ringed spaces  $(X; O_X)$ , and in which a map

$$f = (f_1; f_2) : (X; O_X) ! (Y; O_Y)$$

is a map of spaces

$$f_1: X ! Y$$

and a map of sheaves of algebras over X

$$f_2: O_X ! f_1^{-1}O_Y$$
:

Let  $Sub(\mathbb{T})$  be the category of closed subgroups of  $\mathbb{T}$  with morphisms given by inclusions. We shall de ne E to be a functor

$$E: (\mathbb{T}\text{-spaces}) \ ! \ S^{Sub(\mathbb{T})}$$

from  $\mathbb{T}$ -spaces to the category of  $Sub(\mathbb{T})$ -diagrams in S.

Let X be a  $\mathbb{T}$ -space. The ringed space  $E(X)(\mathbb{T})$  is just

$$E(X)(\mathbb{T}) = \operatorname{sp} E(X^{\mathbb{T}})$$
 C

(which is empty if  $X^{\mathbb{T}}$  is). If  $\mathbb{T}[N]$   $\mathbb{T}$  is a nite subgroup and  $X^{\mathbb{T}[n]}$  is empty, then

$$E(X)(\mathbb{T}[N]) = ::$$

Otherwise,

$$E(X)(\mathbb{T}[N]) = C[N];$$

with structure sheaf  $j^{-1}E_{\mathbb{T}}(X)$ , where j denotes the inclusion

$$j:C[N]$$
!  $C$ .

Explicitly, for 
$$U$$
  $C[N]$ ,  $E(X)(\mathbb{T}[N])(U)$  is the product 
$$E(X)(\mathbb{T}[N])(U) = E_{\mathbb{T}}(X)_a = E_{\mathbb{T}}(X^A)_a;$$

over a 2 U of the stalks of Grojnowski's elliptic cohomology. For  $A = \mathbb{T}[N]$ with  $X^B$  empty, the map

$$E(X)(A)$$
 !  $E(X)(B)$ 

is trivial; otherwise it is induced by the map of sheaves of algebras over C

$$E_{\mathbb{T}}((X^A))$$
 !  $E_{\mathbb{T}}((X^B))$ 

by restriction to C[N].

**Proposition 10.3** Let G be a simple and simply connected Lie group, and let Q be a principal G-bundle over a  $\mathbb{T}$ -space X. Then there is a canonical map

$$E(Q): E(X) ! T C=W$$

in  $S^{Sub(\mathbb{T})}$ , where T C=W is considered as a constant  $Sub(\mathbb{T})$ -diagram, such that the diagram

commutes, and such that for all components F of  $X^{\mathbb{T}}$  and all reductions

$$m: \mathbb{T} ! T$$

of the action of  $\mathbb{T}$  on  $\mathcal{O}_{j_F}$ ,

$$E((Qj_F))(\mathbb{T}) = \operatorname{sp} E(Q(m)) + m$$
:

The proof will occupy the rest of this section.

Let A be a closed subgroup of  $\mathbb{T}$ . Let Y be a connected component of  $X^A$ . A reduction

$$m:A!$$
 T

of the action of A on  $Q_{iy}$  determines a map

$$C(A) \stackrel{C}{\longrightarrow} T (T \quad C)^{W(m)};$$

as usual if  $a \ge C(A)$  we write  $a^m$  for the resulting element of  $(T - C)^{W(m)}$ . The addition

induces a translation

$$(T \quad C)^{W(m)} \quad T \quad C=W(m) \stackrel{?}{+} \quad T \quad C=W(m)$$

and so we get an operator

$$a^m: T \quad C=W(m) ! T \quad C=W(m)$$
:

If  $A = \mathbb{T}$ , then we de ne

$$E(Q)(\mathbb{T})_{Y;m} = \operatorname{sp} E(Q(m)) + m;$$

as required by the Proposition. If A is nite, then we de ne the map of ringed spaces  $E(Q)(A)_{Y;m;a}$  to be the composition

$$E(Y)(A)_{a} \xrightarrow{E(Q)(A)_{Y;m;a}} T \quad C=W(m)$$

$$\downarrow \qquad \qquad \qquad \uparrow \qquad \qquad \uparrow \qquad \qquad \downarrow \qquad \qquad \uparrow \qquad \qquad \downarrow \qquad \qquad \qquad \qquad \downarrow \qquad \qquad \qquad \qquad \downarrow \qquad \qquad \qquad \downarrow \qquad \qquad \qquad \qquad \qquad$$

Here we have used the fact that the  $E(Y)(A)_0$  is just the origin in C, with ring

$$\left(O_{\operatorname{sp}E_{\mathbb{T}}(Y)}\right)_0=H(Y)_0;$$

Lemma 4.3 provides the map 
$$(\mathcal{O}_H)_0$$
. We de ne
$$E(\mathcal{O})(A)_{Y;m} = E(\mathcal{O})(A)_{Y;m;a} : E(Y)(A) ! T C=W(m) :$$

$$= \frac{\partial \mathcal{O}(A)_{Y;m}}{\partial \mathcal{O}(A)_{Y;m;a}} = \frac{\partial \mathcal{O}(A)_{Y;m;a} \cdot E(Y)(A)_{X;m;a} \cdot E(Y)_{X;m;a} \cdot E$$

**Lemma 10.4** If m and  $m^{\parallel}$  are two reductions of the action of A on  $Q_{i_Y}$ , then the diagram

$$E(Y)(A) \qquad \frac{E(Q)(A)_{Y;T}}{T} \qquad T \qquad C=W(M)$$

$$E(Q)(A)_{Y;m^0} \stackrel{?}{y} \qquad \qquad \stackrel{?}{y} \qquad \qquad (10.5)$$

$$T \qquad C=W(M^0) \qquad --\frac{1}{T} \qquad T \qquad C=W$$

commutes.

**Proof** This follows from the fact, proved in Lemma 3.6, that m and  $m^{\ell}$  di er by an element of the Weyl group of G.

The lemma permits us to write  $E(Q)(A)_Y$  for the map

$$E(Y)(A)$$
!  $T C=W$ 

described by (10.5). We de ne

$$E(Q)(A): E(X)(A) = {\stackrel{\mbox{\scriptsize a}}{=}} E(Y)(A) \stackrel{\coprod E(Q)(A)}{=} T C=W;$$

where the coproduct is over the components Y of  $X^A$ . The maps E(Q)(A) as A ranges over closed subgroups of  $\mathbb{T}$  assemble to give the map E(Q) of Proposition 10.3.

## **10.2** Relationship to the theory $E_{\mathbb{T}}$

The construction in Proposition 10.3 is closely related to the theory  $E_{\mathbb{T}}$ . We shall briefly explain how this works, as the explanation sheds light on the relationship between the \transfer argument" of Bott-Taubes and the geometry of the variety (T C)=W:

Suppose that a is a special point of C of order N and let  $A = \mathbb{T}[N]$ . By de nition we have a map

$$E(X)(A)_a$$
! sp  $E_{\mathbb{T};a}(X)$ ;

indeed it is the inclusion of the stalk at a. Suppose that b is an ordinary point, and let  $U = U_a \setminus U_b$ . Suppose that F is a component of  $Y^{\mathbb{T}}$ . Let


$$m_F: \mathbb{T} ! T$$

be a reduction of the action of  $\mathbb{T}$  on  $\mathcal{Q}_{j_F}$ ; we write

$$m_Y = m_F j_A$$

for the resulting reduction of the action of A on  $Qj_Y$  as in Lemma 3.9.

Consider the diagram:



The commutativity of the rectangle on the left is just the de nition of ab. The commutativity of the rectangle on the right is evident. The commutativity of the top and bottom rectangles in the middle is the de nition of E(Q): The commutativity of the remaining rectangles in the middle follows from the group structure on C and T C, together with the de nitions of the maps involved.

**Remark 10.7** We conclude this paper where the research for it began, with an explanation of the relationship between \transfer formula" of [7] and the diagram (10.6). Let  $F = Y^T = Y = X^{T[N]}$  be as above. Let

$$m \ 2 \ T = hom(\mathbb{T}; T)$$

be a reduction of the action of  $\mathbb{T}$  on  $Qj_F$  (so  $m_Y = mj_{\mathbb{T}[N]}$  is a reduction of the action of  $\mathbb{T}[N]$  on  $Qj_Y$ ). Let  $2 O(T \mathbb{G}_a^{\mathrm{an}})^W$  be a theta function for G; it determines a holomorphic characteristic class for principal G-bundles of the form  $Q_{\mathbb{T}}$ : that is, the characteristic class  $(Q_{\mathbb{T}})$  lies in  $H(X; \mathbb{A}_{\mathrm{an}}^1)$ .

The rst point is that, for any  $a \ 2 \ \mathbb{G}_a^{\mathrm{an}}$ ,  $a^m \ 2 \ O(T \ \mathbb{G}_a^{\mathrm{an}})^{W(m)}$ , so it gives a holomorphic characteristic class for principal Z(m)-bundles. Moreover, the commutativity of the diagram

implies that

$$_{a}(\ (Qj_{F}))=(\ _{a}m_{F}\ )(Q(m_{F}))\ 2\ H(F;\mathbb{A}_{\mathrm{an}}^{1}):$$

The second point is that, if  $a \ 2 \ C[N]$ , and  $\overline{a}$  is a lift of a to  $\mathbb{A}^1_{an}$ , then  $\overline{a}^m$  is nearly invariant under the action of  $W(m_Y)$ . Precisely, if  $W \ 2 \ W(m_Y)$ , then

$$\overline{a}^{wm} = \overline{a}^m +$$

for some 2T: that is,  $\overline{a}^{wm}$  and  $\overline{a}^m$  are related by the action of the a ne Weyl group of G. Since is a theta function for G, the relationship between  $\overline{a}^m$  and  $\overline{a}^{wm}$  is controlled by  $c_2(O_{\mathbb{T}})$  When this class is zero, or when the second Chern class of another bundle cancels it, then we may suppose that we have a characteristic class

$$(a_{\overline{a}^{m_Y}})(Q(m_Y)) \ 2 \ H(Y; \mathbb{A}^1_{\mathrm{an}}) :$$

We then have

$$(a^{m_Y})(Q(m_Y))j_F = (a^{m_Y})(Q(m)) = a(Qj_F));$$

which is a typical \transfer formula".

# 10.3 The nonequivariant case

The conjecture is interesting already in the nonequivariant case. In order to compare with [2], we suppose that V is an SU(d)-bundle over a space X: Let T SU(d) be the usual maximal torus, with Weyl group W. Let  $C = \mathbb{C}$ = be a complex elliptic curve, and let E be the associated elliptic spectrum.

We then have a map

which in *E*-theory gives (by the splitting principle) a map

$$X_F \not= BSU(a)_F = (T \not b) = W$$
:

The line bundle I(V) = f(I) is certainly canonically isomorphic to  $V_E$ : this follows simply from the fact that the sigma function is of the form

$$(z) = z + o(z^2):$$

Of course the line bundle A(V) is trivial when restricted to T  $\mathcal{E}=W$ . But if  $c_2V=0$ , then A(V) has a canonical trivialization, since A(V) descends from the line bundle  $L(c_2)$  over T C de ned by

$$L(c_2) = \frac{T \quad (\mathbb{G}_m^{\mathrm{an}}) \quad \mathbb{C}}{(u; \quad ) \quad (uq^m; u^{\hat{T}(m)}q^{(m)})}$$

(see (5.8)). It follows that (V) gives a trivialization of

$$A(V)$$
  $I(V) = V_F$ :

Notice that we only needed  $c_2V=0$  to get a trivialization of A(V): this is because our elliptic curve is of the form  $C=\mathbb{C}^{=}$ , and the construction of  $L(c_2)$  uses the covering of C.
